IT IS HEREBY DECLARED that Pursuant to section 22B(3)(a) of the Anti-Terrorism Act, Chap. 12:07, the Defendant, MOHAMMED also known as MASOOD also known as AZHAR also known as ALVI also known as also known as Masud Azhar also known as Wali Adam Isah also known as Wali Adam Esa, DOB:

  - (iii) derived or generated from funds or other assets owned or controlled directly or indirectly by the Defendant,

be frozen;

- Pursuant to section 22B(4D)(b) of the Act, the Registrar
  of the Supreme Court do serve an Office Copy of the
  Order on the Financial Intelligence Unit immediately in
  accordance with the Civil Proceedings Rules 1998 (as
  amended);
- 4. Pursuant to section 22B(5) of the Act, the Attorney General shall within seven (7) days after the date of this Order, cause a copy of the Order and a statement that the matter will be reviewed every six (6) months, to be published in the Trinidad and Tobago Gazette and in two (2) daily newspapers of general circulation in Trinidad and Tobago; and
- Liberty to apply.
