# NOTICE OF SUBMISSION FOR PUBLIC COMMENT ON THE DRAFT REVISED WATER POLLUTION RULES (WPR) OF TRINIDAD AND TOBAGO

Issued under sections 26, 27, 28 and 52 of the Environmental Management Act

**NOTICE** is hereby given, upon the direction of the Minister of Planning and Development, that the draft Revised Water Pollution Rules ("the WPR") prepared by the Environmental Management Authority ("the Authority") under sections 26, 27, 28 and 52 of the Environmental Management Act, Chap. 35:05 ("the Act") is now available for public comment. The revision of the WPR is deemed necessary given the vast changes to the environmental, development, economic and social paradigm of Trinidad and Tobago since the implementation of the WPR in 2007.

And take notice that the Authority has, pursuant to Section 28(I)(b) of the Act, established an Administrative Record including a copy of the draft Revised Water Pollution Rules, a written description of the proposed action, the major environmental issues involved in the matter under consideration, copies of relevant documents or other supporting materials which the Authority believes would assist the public in developing a reasonable understanding of those issues and of the Authority's reasons for the proposed action.
