ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (LABOUR DAY CELEBRATIONS—FYZABAD) ORDER, 2019

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Labour Day Celebrations—Fyzabad) Order, 2019.
- 2. This Order shall have effect between the hours of 6.00 a.m. to Duration 12.00 midnight on Wednesday 19th June, 2019.
- 3. (1) Parking is prohibited between the hours of 6.00 a.m. and Parking 12.00 midnight, on—
 - (a) Fyzabad-Guapo Road, between Uriah Butler Avenue and Gowers Well Road;
 - (b) Easy Street, between Fyzabad-Guapo Road and Coolman Trace:
 - (c) Coolman Trace, between Easy Street and Fyzabad-Guapo Road;
 - (d) Fyzabad-Guapo Road, between Coolman Trace and Uriah Butler Avenue;
 - (e) Lum Tack Hill;
 - (f) Delhi Road, between Fyzabad-Oropouche Road and Mon Desir-Delhi Road;
 - (g) Fyzabad-Oropouche Road, between Fyzabad Junction and Avocat Junction;
 - (h) Gowers Well Road, between Fyzabad-Guapo Road and Patterson Street;
 - (i) John Jules Trace, between Delhi Road and Gowers Well Road;
 - (j) Uriah Butler Avenue; and
 - (k) Fyzabad-Oropouche Road, between Lum Tack Hill and Jimdar Street.

- (2) Parking is prohibited between the hours of $6.00~\mathrm{a.m.}$ and $12.00~\mathrm{noon}$, on—
 - (a) Siparia Old Road, between Avocat Junction and Samlal Trace; and
 - (b) Fyzabad-Oropouche Road, between Avocat Junction and Jebodhsingh Street.

Vehicular traffic prohibited 4. Vehicular traffic is prohibited on Fyzabad-Guapo Road, between Uriah Butler Avenue and Charlie King Junction between the hours of 6.00 a.m. and 12.00 midnight.

Alternate routes

- 5. (1) A driver entering Fyzabad from Oropouche along the Oropouche Road shall—
 - (a) proceed from Avocat Junction, in a south-easterly direction onto Siparia Old Road, and then turn right onto Fyzabad-Guapo Road;
 - (b) turn left at Ralph Narine Trace, then right onto St. John's Trace, then right onto Avocat-Siparia Old Road, and then left onto Fyzabad-Oropouche Road; or
 - (c) turn right onto Berridge Trace, then left onto Mon Desir-Delhi Road, then right onto John Jules Trace, then left onto Delhi Road and then left onto Gowers Well Road.
- (2) A driver entering Oropouche from Fyzabad shall proceed in a south-easterly direction along Fyzabad-Guapo Road, then turn left onto Siparia Old Road, then turn right onto St. John's Trace, then turn left onto Ralph Narine Trace, and then right onto Oropouche Road.
- (3) A driver entering Siparia from Fyzabad or Forest Reserve shall proceed in an easterly direction onto Uriah Butler Avenue, and continue onto Fyzabad-Guapo Road.
- (4) Notwitstanding paragraph (3), a driver entering Siparia from Fyzabad shall proceed along Delhi Road, onto Gowers Well Road, then turn right onto Fyzabad-Guapo Road and then turn either—
 - (a) left onto Uriah Butler Avenue; or
 - (b) right onto Oilfield Road,

and continue onto Spring Trace, between the hours of $2.00~\mathrm{p.m.}$ and $10.00~\mathrm{p.m.}$

Emergency routes

- 6. A driver who has an emergency shall proceed—
 - (a) to San Fernando from Fyzabad, along Delhi Road, onto Lutchman Drive, continue onto Sewlal Trace, and then turn left onto Fyzabad-Oropouche Road; and

- (b) to Siparia from Fyzabad—
 - (i) along Delhi Road, turn right onto John Jules Trace, then left onto Gowers Well Road, then right onto Guapo Road, then left onto either Butler Avenue or Sanderson Avenue; or
 - (ii) along Guapo Road, then turn left onto Field Road No. 34 and proceed to Siparia Road.
- 7. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in impounding contravention of this Order may be removed by the police and unlawfully impounded and dealt with in accordance with section 108(1)(b) of the parked Motor Vehicles and Road Traffic Act.
