THE CONSERVATION OF WILD LIFE ACT, CHAP. 67:01

REGULATIONS

Made by the Minister under section 24(1) of the Conservation of Wild Life Act

THE CONSERVATION OF WILD LIFE (AMENDMENT) REGULATIONS, 2019

1. These Regulations may be cited as the Conservation of Wild Life Citation (Amendment) Regulations, 2019.

2. In these Regulations, "the Regulations" means the Conservation Interpretation of Wild Life Regulations.

3. The Act is amended—

Second and Third Schedules to the Act

(a) in Part II of the Second Schedule by deleting the following:

"Herons: Great blue heron (Adrea herodias), Cocoi heron amended (Adrea cocoi), Black-crowned night heron (Nycticorax nycticorax), Yellow-crowned night heron (Nyctanassa violacea), Boat-billed heron (Cochlearius)

Neotropic Cormorant (Phalacrocorax brasilianus)

Rallidae: All birds belonging to the Family Rallidae (*Coots, Rails, Gallinules and their allies*)

Wild Ducks: Black-bellied whistling duck (Dendrocygna autumnalis), Fulvous whistling duck (Dendrocygna bicolor), Muscovy (Cairina moschata)."; and

(*b*) in the Third Schedule by adding the following:

"Capybara (Hydrochoerus hydrochaeris)".

4. Regulation 2 of the Regulations is amended in subregulation (4), Regulation 2 by deleting the words "two hundred dollars" and substituting the ^{amended} words "five thousand dollars or two thousand five hundred dollars, respectively.".

5. Regulation 4 of the Regulations is amended in subregulation (4), Regulation 4 by deleting the words "two hundred dollars" and substituting the words "two thousand dollars".

Regulation 4A amended	6. Regulation 4A of the Regulations is amended in subregulation (2), by deleting the words "two hundred dollars" and substituting the words "two thousand dollars".
Regulation 5 amended	7. Regulation 5 of the Regulations is amended in subregulation (2), by deleting the words "two hundred dollars" and substituting the words "two thousand, five hundred dollars".
Regulation 6 amended	8. Regulation 6 of the Regulations is amended—
	(a) in subregulation (1), by inserting after the word "sell", the words ",offer, advertise for sale";
	(b) in subregulation (1A), by inserting after the word "sell", the words ",offer, advertise for sale";
	(c) by inserting after subregulation (1B), the following sub- regulation:
	" (1C) In addition to the prohibitions set out in sub- regulation (1), no person shall have in his possession, serve, purchase, sell, offer, advertise for sale or expose for sale from 1st January to 31st March annually, any iguana which fall under the category of lizards referred to in Part I of the Second Schedule to the Act."; and
	(d) in subregulation (2)—
	(i) by deleting the words "or (1A)" and substituting the words ", (1A) or (1C)"; and
	(ii) by deleting the words "two hundred dollars" and substituting the words "ten thousand dollars";
Regulation 7 amended	9. Regulation 7 of the Regulations is amended—
	(a) in subregulation (1), by deleting the word "No" and substituting the words "Subject to subregulation (1A), no";
	(b) by inserting after subregulation (1), the following sub- regulation:
	" (1A) Where the animal referred to in the Second Schedule to the Act is a lizard, no person shall hunt or be a member of a party engaged in hunting lizards in any Forest Reserve at any time, within the municipal boundaries of the city of Port-of-Spain."; and
	(c) in subregulation (2)—
	(i) by inserting after the words "(1)", the words "or (1A)"; and
	(ii) by deleting the words "two hundred dollars" and substituting the words "five thousand dollars".

10. The Regulations is amended by inserting after regulation 7, the Regulation 7A following regulation:

(2) Any person who contravenes the provision of subregulation (1) is liable on summary conviction to a fine of five thousand dollars.

Chap. 67:01 (3) The power of the Chief Game Warden to authorise hunting of lizards within the municipal boundaries of the city of Port-of-Spain under section 6 of the Act is hereby suspended.".

11. Regulation 8 of the Regulations is deleted.

Regulation 8 deleted Regulation 9

12. Regulation 9 of the Regulations is amended in subregulation (2), Regulation 9 by deleting the words "two hundred dollars" and substituting the words ^{amended} "five thousand dollars".

13. Regulation 10 of the Regulations is amended in subregulation (2), Regulation 10 by deleting the words "two hundred dollars" and substituting the words ^{amended} "five thousand dollars".

14. Regulation 14 of the Regulations is amended in subregulation (2), Regulation 14 by deleting the words "two hundred dollars" and substituting the words ^{amended} "one thousand dollars".
