MADE BY THE MINISTER UNDER SECTION 8A(1) OF THE CUSTOMS ACT

THE COMMON EXTERNAL TARIFF (SUSPENSION) (NO. 4)
ORDER, 2019

1. This Order may be cited as the Common External Tariff Citation
(Suspension) (No. 4) Order, 2019.

2. The rates of duty set out in the First Schedule to the Customs Act, in relation to the goods carrying the headings and descriptions listed below in the First and Second Columns respectively, are suspended for the period specified in the Third Column.

3. This Order is deemed to have come into force on 16th November, 2019.
