ORDER

MADE BY THE MINISTER UNDER SECTION 8A(1) OF THE CUSTOMS ACT

THE COMMON EXTERNAL TARIFF (SUSPENSION) (NO. 5) ORDER, 2019

- 1. This Order may be cited as the Common External Tariff Citation (Suspension) (No. 5) Order, 2019.
- 2. In this Order, where "Ex" is used in relation to an item number Interpretation under a heading listed in the First Column of the First Schedule to the Customs Act, that item number shall refer only to the corresponding goods described in the Second Column.
- 3. The rates of duty set out in the First Schedule to the Customs Suspension Act, in relation to the goods carrying the headings and descriptions of duty in the listed below in the First and Second Columns respectively, are Schedule suspended for the period specified in the Third Column—
