ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(REPUBLIC OF TRINIDAD AND TOBAGO FIFTY-SEVENTH
ANNIVERSARY OF INDEPENDENCE CELEBRATIONS)
ORDER, 2019

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Republic of Trinidad and Tobago Fifty-Seventh Anniversary of Independence Celebrations) Order, 2019.

2. This Order has effect between 6.00 p.m. on Friday 30th August, Duration 2019 to 1.00 a.m. on Sunday 1st September, 2019.

3. No person shall park a motor vehicle—

Parking
prohibited

(a) from 6.00 a.m. to 12.00 noon on Saturday 31st August, 2019, on—

- (i) Queen's Park West, between Queen's Park East and Cipriani Boulevard;
- (ii) Chancery Lane, between Keate Street and Queen's Park West;
- (iii) Dere Street;
- (iv) Albion Street;
- (v) Gordon Street;
- (vi) Frederick Street, between Queen's Park West and Park Street;
- (vii) Park Street, between Frederick Street and St. Vincent Street;
- (viii) Western Main Road, from its junction with Tragarete Road and its junction with Long Circular Road; and
- (ix) Tragarete Road;

- (b) from 6.00 a.m. to 2.00 p.m. on Saturday 31st August, 2019, on—
 - (i) Phillip Street, between Tragarete Road and Kew Place; and
 - (ii) Fraser Street, between Phillip Street and Richmond Street;
- (c) from 6.00 a.m. to 3.00 p.m. on Saturday 31st August, 2019, on Long Circular Road, between Western Main Road and Patna Street; and
- (d) from 12.00 noon on Saturday 31st August, 2019 to 1.00 a.m. on Sunday 1st September, 2019 on—
 - (i) Queen’s Park West, between Chancery Lane and St. Clair Avenue;
 - (ii) Maraval Road, between St. Clair Avenue and Saddle Road;
 - (iii) Circular Road, between Saddle Road and St. Ann’s Road;
 - (iv) Queen’s Park East, between St. Ann’s Road and Queen’s Park West; and
 - (v) Charlotte Street, between Queen’s Park West and New Street.

Vehicular
traffic
prohibited

4. No person shall drive a motor vehicle—

- (a) from 9.00 a.m. to 10.00 a.m. on Saturday 31st August, 2019, on—
 - (i) Queen Park West, between Queen’s Park East and Chancery Lane;
 - (ii) Keate Street, between Charlotte Street and Abercromby Street;
 - (iii) Frederick Street, between Queen’s Park West and Park Street; and
 - (iv) Pembroke Street, between Keate Street and Gordon Street;
- (b) from 7.00 a.m. to 11.00 a.m. on Saturday 31st August, 2019, on Park Street, between Henry Street and Edward Street;

- (c) from 7.00 a.m. to 12.00 noon on Saturday 31st August, 2019,
on—
- (i) Tragarete Road; and
 - (ii) Western Main Road, between Damian Street and
Lucknow Street;
- (d) from 6.00 p.m. on Friday 30th August, 2019 to 1.00 a.m. on
Sunday 1st September, 2019 on Fraser Street, between
Phillip Street and Richmond Street; and
- (e) from 6.00 a.m. on Saturday 31st August, 2019 to 1.00 a.m.
on Sunday 1st September, 2019 on Phillip Street, between
Tragarete Road and Kew Place.

5. A driver of a motor vehicle may park the vehicle in the Queen's ^{Parking in} Park Savannah, from 6.00 a.m. to 11.00 a.m. on Saturday 31st August, ^{Queen's Park} 2019, as directed by a police officer on duty. ^{Savannah}

6. Without prejudice to any other liability incurred by the ^{Removal and} commission of a summary offence, vehicles found parked in ^{impounding of} contravention of this Order may be removed by the Police and ^{vehicles} impounded and dealt with in accordance with section 108(1)(b) of the ^{unlawfully} Motor Vehicles and Road Traffic Act. ^{parked}
