THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(FORMAL OPENING OF THE 2019–2020 LAW TERM OF
THE SUPREME COURT OF JUDICATURE OF THE
REPUBLIC OF TRINIDAD AND TOBAGO) ORDER, 2019

1. This Order may be cited as the Traffic Restriction (Temporary ^{Citation}
Provisions) (Formal Opening of the 2019–2020 Law Term of the
Supreme Court of Judicature of the Republic of Trinidad and Tobago)
Order, 2019.

2. This Order has effect from 6.00 a.m. to 2.00 p.m. on Monday ^{Duration}
16th September, 2019.

3. (1) No person shall park a motor vehicle on—

prohibited</sup>

- (a) St. Vincent Street, between Duke Street and Independence Square North;
- (b) Sackville Street, between Richmond Street and St. Vincent Street;
- (c) Abercromby Street, between Independence Square North and Park Street;
- (d) Knox Street, between Abercromby Street and Frederick Street;
- (e) Edward Street, between Independence Square North and Park Street;
- (f) Hart Street;
- (g) Duke Street, between Frederick Street and Edward Street;
- (h) Pembroke Street, between Knox Street and Park Street;
- (i) Henry Street, between Independence Square North and Park Street;
- (j) Queen Street, between Frederick Street and Edward Street; and
- (k) the Red House Grounds.

(2) Notwithstanding subclause (1), a driver of a motor vehicle belonging to the Police Service and the Defence Force may park on the eastern side of Edward Street, between Queen Street and Sackville Street.

4. No person shall drive a motor vehicle, from 9.00 a.m. to 1.00 p.m., on—
- (a) St. Vincent Street, between Duke Street and Queen Street;
 - (b) Hart Street;
 - (c) Abercromby Street, between Independence Square North and Park Street;
 - (d) Knox Street; and
 - (e) Pembroke Street.

Vehicular
traffic
diverted

5. A person driving a motor vehicle from 9.00 a.m. to 1.00 p.m.—
- (a) east along Sackville Street, shall turn south onto Richmond Street;
 - (b) west along Duke Street, shall turn south onto Frederick Street; and
 - (c) south on St. Vincent Street, shall turn west onto Duke Street.

Taxi routes

6. A taxi driver plying—
- (a) the St. Ann's route from Hart Street, shall operate from the northern side of Queen Street, between Frederick Street and St. Vincent Street; and
 - (b) the St. James route from Hart Street, shall operate from the northern side of Independence Square North, between Frederick Street and Henry Street.

Removal

7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order, may be removed and impounded by any member of the Police Service in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
