THE FINANCE (VARIATION OF APPROPRIATION)  
(FINANCIAL YEAR 2019) BILL, 2020

**Explanatory Note**

(These notes form no part of the Bill but are intended only to indicate its general purport)

The Bill seeks to vary the appropriation of the sum the issue of which was authorised by the Appropriation (Financial Year 2019) Act, 2018 (Act No. 16 of 2018) and varied by the Finance (Supplementary Appropriation) (Financial Year 2019) Act, 2019 (Act No. 9 of 2019) and to authorise the utilisation of any sums accruing from a reduction in expenditure under certain Heads of Expenditure for the purpose of meeting liability incurred through the increase in expenditure under other Heads.

## **BILL**

AN ACT to vary the appropriation of the sum the issue of which was authorised by the Appropriation (Financial Year 2019) Act, 2018 and varied by the Finance (Supplementary Appropriation) (Financial Year 2019) Act, 2019

ENACTED by the Parliament of Trinidad and Tobago as Enactment follows:

Short title	<b>1.</b> This Act may be cited as the Finance (Variation of Appropriation) (Financial Year 2019) Act, 2020.
Interpretation Act No. 16 of 2018 Act No. 9 of 2019	<b>2.</b> In this Act, “the Appropriation Act, 2018” means the Appropriation (Financial Year 2019) Act, 2018 as amended by the Finance (Supplementary Appropriation) (Financial Year 2019) Act, 2019.
Increase in Heads of Expenditure Schedule	<b>3.</b> The sums appropriated to the Heads of Expenditure specified in the First Column of Part I of the Schedule to this Act by the Appropriation Act, 2019 are increased by the amount specified in the Second Column of that Part.
Reduction in Heads of Expenditure Schedule	<b>4.</b> The sums appropriated to the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 2019 are reduced by the amount specified in the Second Column of that Part.
Sums appropriated in respect of Heads specified in Part II may be utilised Schedule Chap. 69:01	<b>5.</b> The sums appropriated in respect of the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 2019 and not utilised at the commencement of this Act may be utilised, notwithstanding, anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Heads of Expenditure specified in the First Column of Part I of the Schedule to this Act.
