THE LEGAL PROFESSION ACT, CHAP. 90:03

RULES

Rules made by the Council of the Law Association of Trinidad and Tobago, pursuant to paragraph 26(1) of Part A of the First Schedule of the Legal Profession Act No. 21 of 1986.

The following Rules shall replace all previous Rules made under paragraph 26(1) of Part A of the First Schedule of the Legal Profession Act No. 21 of 1986.

Rules Governing General Meetings

(1A) A General Meeting of the Association may be held at any place within Trinidad and Tobago as the Council may determine and/or virtually by electronic media approved by the Council and notified to the members in accordance with these Rules.

(1B) Participation by members entitled to vote at a General Meeting may be wholly or in part by physical presence or by means of electronic or virtual communication facilities prescribed by the Council as permit all members participating in the meeting to hear each other and communicate with each other simultaneously and instantaneously (hereinafter called "the Prescribed Electronic Media"). A member participating in a General Meeting by the Prescribed Electronic Media shall be deemed to be present in person at that meeting.

(1) Fifty (50) practitioner members present in person shall constitute a quorum at a General Meeting.

(2) No business shall be transacted at any General Meeting except the adjournment of the meeting unless a quorum of members is present at the time when the meeting proceeds to business.

RULES—Continued

- (3) Save in the case of a Special General Meeting requisitioned under paragraph 23 in Part A of the First Schedule, if within half an hour from the time appointed for the meeting a quorum is not present the meeting shall stand adjourned to the same day in the next week, at the same time and place (if physical) and/or via the Prescribed Electronic Media and on such adjourned date the members present shall constitute a quorum notwithstanding their number be less than fifty (50).
- (4) Fourteen (14) days' notice specifying the place and/or the Prescribed Electronic Media, day and hour of every General Meeting shall be given to such persons as are entitled to receive such notice. If special business is to be conducted at any General Meeting the nature thereof shall be specified in the notice of such meeting. Notice shall be deemed to have been given to a member if either it is sent to him by ordinary mail at the address given by him in the roll of practitioners or notified by him to the Secretary or by electronic mail sent to the address notified to the Secretary and if published twice in a daily newspaper. The accidental omission to give notice of a meeting to, or the non-receipt of notice of a meeting by, any member shall not invalidate the proceedings of any meeting.
- (5) the Chairman may with the consent of the majority of members at any meeting at which a quorum is present (and shall if a motion for the purpose has been passed) adjourn any meeting from time to time and from place to place but no business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place.
- (6) At any General Meeting every question or resolution (save for the election of officers and members of the Council) shall be decided by a show of hands (in respect of those present at a physical meeting) and/or by electronic means in respect of those participating virtually by way of the Prescribed Electronic Media unless a poll be demanded by at least ten (10) members. A declaration by the Chairman that a resolution has been carried or not carried and an entry to that effect in the record of the proceedings of the Association shall be conclusive evidence of the facts.

RULES—Continued

- (7) A poll shall be taken at such time before the conclusion of the meeting or any adjournment thereof and in such manner (physically and/or virtually via the Prescribed Electronic Media) as the Chairman may appoint and the result of such poll shall be deemed to be the resolution of the Association in General Meeting. In case of any dispute as to admission or rejection of any vote the Chairman shall determine the same and such determination made in good faith shall be final and conclusive.
- (8) A poll demanded upon a question of adjournment shall be taken forthwith. Business other than that upon which a poll has been demanded may be proceeded with pending the taking of the poll.
