TENDERS are invited for the Supply and Delivery of Three (3) Modular Steel Bridges for the Ministry of Rural Development and Local Government.

Tenders must be accompanied by valid:

- (a) Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender. (applicable to local firms);
- (b) Certificate of Compliance issued in accordance with the National Insurance Act. (applicable to local firms)

An original and three (3) copies of the tender must be placed in sealed envelopes clearly marked on the outside: "Tender for the Supply and Delivery of Three (3) Modular Steel Bridges for the Ministry of Rural Development and Local Government."

Envelopes must be addressed to the Chairman, Central Tenders Board, 116, Frederick Street, Port-of-Spain and must be deposited in the Brown Tenders Box located in the lobby of the Board's Office not later than 1.00 p.m. on Thursday 6th August, 2020.

Tenderers should note that the dimensions of the slot on the Tenders Box are 37.5 cm x 5.5 cm and as such, tenders should be packaged accordingly.

The Tender opening will be streamed live via Webex and Tenderers shall be provided with a link that will connect them to the live proceedings.

Late tenders will not be considered in any circumstances.
