- 2) Please note that the Amateur Radio Licence Application (L2) form shall be used for a person wishing to apply for an Amateur Licence
- 2) Complete and email the form along with copies of relevant documents to info@tatt.org.tt.
- 3) Upon receipt of the application, TATT will contact you regarding the appropriate application fee, payment options, any other required information and instructions for collection/delivery of the licence.
