"The Implementation Division of the Trinidad and Tobago Bureau of Standards (TTBS) is responsible for the enforcement of Compulsory Standards and other enforceable Regulations, and is guided by the Standards Act No. 18 of 1997.

Section 15 (3) of the Standards Act states "The Bureau may charge fees for services rendered under this section and may offer these services inside or outside of Trinidad and Tobago". Inspection activities are covered by regulatory fees as outlined in the Inspection Fee Schedule 2020. In addition to the Inspection Fee plus VAT, used goods also incur a Performance Deposit which is refunded after the inspection is complete, minus the cost of non-conforming items. This fee may be forfeited by failure to make said goods available for inspection. Certain types of goods, due to the level of risk to the consumer, must also be subjected to performance testing and a Testing Fee is levied in those instances."
