TRINIDAD AND TOBAGO SECURITIES AND EXCHANGE COMMISSION

In the Matter of Section 155(1A)(e) and 159(10) of the Securities Act, Chapter 83:02 of the Laws of the Republic of Trinidad and Tobago (the “Act”)

and

In the Matter of the Impact of the Novel Coronavirus Disease 2019 (“COVID-19”) pandemic on the Submission of Continuous Disclosures and Filings by Registrants and non-Registrants

ORDER OF THE COMMISSION

Dated this 25th day of MARCH, 2020

WHEREAS:

1. Registrants and non-Registrants are required to comply with the continuous disclosure and filing requirements within the prescribed timeframes under the *Securities Act Chapter 83:02 of the Laws of the Republic of Trinidad and Tobago* (the “Act”) and the *Securities (General) By-laws, 2015* (the “By-laws”);
2. The Commission can impose administrative penalties on Registrants and non-Registrants under *Section 156(2)* of the Act for each instance where Registrants or non-Registrants fail to file or publish a document or instrument required by the Act or the By-laws;
3. The Government of the Republic of Trinidad and Tobago (“GoRTT”), as well as a number of countries globally, has made specific decisions in response to the Novel Coronavirus Disease 2019 (“COVID-19”) pandemic; and
4. The decisions made by the GoRTT in response to the COVID-19 pandemic may present certain challenges to some Registrants and non-Registrants in submitting timely statutory filings with the Commission within the prescribed timeframes set out in the Act and the By-laws.
5. There are external factors beyond the control of Registrants and non-Registrants, which may hamper their ability to submit filings which are due between the period 16th March 2020 to 20th April 2020 (the “Relevant Period”) on time.
6. This Order does not apply to filings which may have become due before the Relevant Period.

AND UPON

7. The Commission receiving inquiries from Registrants enquiring whether the Commission will be reviewing the potential impact which COVID-19 may have on Persons' ability to meet its continuous disclosure and filing obligations within the stipulated timeframes according to the Act and the By-laws.
8. Registrants indicating that, due to the uncertainty of the impact of COVID-19 on their businesses and the country as a whole, they are anticipating that there will be disruptions in their operations, which will result in their inability to meet certain deadlines as specified in the Act and the By-laws in the near future.
9. This Order being reviewed by the Commission on or before the 20th April 2020.

IT IS HEREBY ORDERED THAT:

Pursuant to Sections 7(1)(n), 155(1A)(e) and 159(10) of the Act, the Commission will not pursue enforcement action for up to thirty (30) days after the due date of a filing where Registrants and non-Registrants are unable to meet their continuous disclosure and filing requirements under the Act and the By-laws for documents which are due to be filed during the period **16th March 2020 to 20th April 2020** provided that such persons file, with the Commission, a Form 6 or other written notification:

- (i) forthwith, where the relevant document became due between 16th March 2020 and the date of the publication of this Order; or
- (ii) before the due date for filing the required document where that filing will become due after the date of publication of this Order.

This Order shall take effect from the 16th day of March 2020

TENDER FOR EXPRESSIONS OF INTEREST FOR CONSULTING SERVICES FOR THE DESIGN, IMPLEMENTATION, MAINTENANCE AND SUPPORT OF A PORT COMMUNITY SYSTEM FOR THE MINISTRY OF TRADE AND INDUSTRY, GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT), INTER-AMERICAN DEVELOPMENT BANK (IDB) LOAN No. 3575/OC-TT

The Government of the Republic of Trinidad and Tobago has received financing from the Inter-American Development Bank (IDB) for the Project, Strengthening of the Single Electronic Window (SEW) for Trade and Business Facilitation. Funding received for the project shall be applied to the above mentioned Consultancy.

The General Objectives of this Consultancy are to design, implement, maintain and support a Port Community System (PCS) for Trinidad and Tobago. The PCS will facilitate port logistics, international and domestic trade and the exchange of information between private and public entities thereby reducing time and costs in these processes.

The System will provide a platform that will allow transactions relating to the planning, management and execution of arrival, berthing and departure of ships in port and loading, unloading, delivery, pick up and transport of cargo and containers. The platform will be implemented and deployed for the Port of Point Lisas and Port of Port-of-Spain, and shall be required to connect and interoperate with the Single Electronic Window Platform (TTBizlink), Custom's system (ASYCUDA), authentication system (TTConnect ID solution), and ports systems (NAVIS).

The Scope of Services for the Consultancy include the following:

- a. Functional Analysis;
- b. Software acquisition and development;
- c. Detailed Design of modules on the platform;
- d. Detailed Technological Infrastructure Design;
- e. Functional architecture design and PCS implementation plan;
- f. Configuration, testing and evolution, documentation, training and deployment of the PCS modules; and
- g. Maintenance and Support PCS.

In this regard, the Central Tenders Board (CTB), on behalf of the Executing Agency, the MTI, invites eligible consulting firm(s) to indicate their interest in providing the Consulting Services. Interested firm(s) must provide information to substantiate their ability to perform the Consulting Services. Submissions shall include, at a minimum, a company profile inclusive of a signed transmittal letter and project summary of experience in similar projects (brochures, reference links of clips highlighting recent work, posters, brochures, radio ads etc., Facebook content etc.) of similar assignments, experience in similar conditions, availability of appropriate skills amongst staff, financial capability, etc.

Firms are also asked to include any risks and challenges they may have encountered in the design and implementation of PCS's implemented as well as, the features and functionalities of their PCS software and systems.

This Consultancy requires the Consulting Firm(s) to have the specific experience and/or capabilities and must substantiate such in the following areas:

- (i) Minimum of five (5) years' experience in:
 - a. Design, Implementation, Maintenance and Support of Port Community Systems (PCS); and
 - b. Development, maintenance and support for information systems for large-scale port logistics for container management, foreign trade, etc., involving several companies, dispatchers, and public agencies, to coordinate their import and export business activities.

Note: For each job, indicate: location, scope of services (including type of modules implemented) including duration of the project implementation and maintenance and support, year approximate breakdown of cost for implementation, maintenance and support of the contract, dimension of the working teams for development, maintenance and support, application of the architecture and the technologies required in the execution of the project.

- (ii) At least two (2) similar projects conducted within the last seven (7) years-with at least one (1) similar project with an amount of more than 2 million US dollars.
- (iii) Qualifications of Key Consultants.

- (a) The duration of the assignment is approximately 24 calendar months for implementation and 36 months of maintenance and support.

Shortlist shall comprise six firms with a wide geographic spread, with no more than two firms from any one country. For the purpose of establishing the shortlist, the nationality of a firm is that of the country in which it is legally incorporated or constituted and in the case of a Joint Venture, the nationality of the firm appointed to represent it.

Consulting Firm(s) which do not provide detailed information on its specific experience and/or capabilities as identified in (i)–(iii) above in the Design, Implementation, Maintenance and Support of a Port Community System and provide only general information on its e-government experience shall not be short-listed.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy. Note, for the purpose of evaluation at this EOI stage the qualifications and experience of the sub-consultancy will not be considered.

A Consultant will be selected in accordance with the Quality Based Selection (QBS) method set out in the Consultant Policies (GN 2350-9).

An original and six (6) copies of the data must be submitted in sealed envelope(s) clearly marked: Expressions of Interest for Consulting Services for the Design, Implementation, Maintenance and Support of a Port Community System for the Ministry of Trade and Industry, Government of the Republic of Trinidad and Tobago (GORTT), Inter-American Development Bank (IDB), Loan No. 3575/OC-TT.
