MADE BY THE MINISTER UNDER SECTION 88D OF THE MOTOR VEHICLES
AND ROAD TRAFFIC ACT

THE MOTOR VEHICLES AND ROAD TRAFFIC (FIXED
PENALTY PAYMENT METHODS AND PAYEE) ORDER, 2020

1. This Order may be cited as the Motor Vehicles and Road Traffic Citation
(Fixed Penalty Payment Methods and Payee) Order, 2020.

2. In this Order—

Interpretation

“Act” means the Motor Vehicles and Road Traffic Act; and

“fixed penalty” means the penalty prescribed under section 84 of
the Act.

3. Payment of a fixed penalty shall be made in cash, electronic form
or by electronic means.

4. (1) The Minister, acting in accordance with section 88D(1)(e) of the
Act, approves the Trinidad and Tobago Postal Corporation as a payee for
the purpose of receiving payment of fixed penalty.

(2) Payment of a fixed penalty under subclause (1) shall be made
at any corporate shop of the Trinidad and Tobago Postal Corporation as
specified in the Schedule.
