OPEN GENERAL LICENCE

IN EXERCISE of the powers conferred on the Minister for the purpose of the Imports and Exports Control Regulations, 1941, as continued in force by section 10 of the Trade Ordinance, No. 19 of 1958, and pursuant to regulation 3(1) of the said Regulations, the Minister hereby gives notice that the OPEN GENERAL LICENCE published as NOTICE TO EXPORTERS NO. 1 OF 1998 is amended by, inserting the following items:
