2. The Commissioner of State Lands is authorized to take possession of the parcel of land comprising 2,622.6 square metres, more or less, being part of a larger parcel of land comprising 10.2343 hectares, situate at Paramin Village, Paramin, in the Ward of Diego Martin, in the County of St George, said to belong now or formerly to Francis Sandy and Others and described in the Notification in the *Trinidad and Tobago Gazette*, Legal Supplement Part B, Volume 58, No. 163, dated 15th November, 2019, at Item No. 2232, as Legal Notice No. 347 of 2019, before the formal vesting of the land in the State, and to apply it to the purpose for which it is intended to be put on acquisition. ^{Possession of land}
