ORDER

MADE BY THE PRESIDENT UNDER SECTION 9 OF THE CUSTOMS ACT

THE CUSTOMS (REMITTANCE OF CUSTOMS DUTY) ORDER, 2020

1. This Order may be cited as the Customs (Remittance of Customs _{Citation} Duty) Order, 2020.

2. For the purposes of clause 3, where the expression "Ex" is used in Interpretation relation to a Tariff Heading listed in the First Column, that Tariff Heading shall refer only to the corresponding goods described in the Second Column.

3. There is a remittance of the customs duty payable in respect of Remittance of the following items, carrying the Tariff Heading and Description of ^{customs duty} Goods set out below in the First and Second Columns, respectively:
