# THE FINANCE (SUPPLEMENTATION AND VARIATION OF APPROPRIATION) (FINANCIAL YEAR 2021) BILL, 2021

#### **Explanatory Note**

(This note forms no part of the Bill but is intended only to indicate its general purport)

The object of the Bill is to supplement and vary the appropriation provided for by the Appropriation (Financial Year 2021) Act, 2020 and to authorise the utilisation of any sum accruing from a reduction of expenditure under a Head of Expenditure for the purpose of meeting any liability incurred through the increase in expenditure under other Heads of Expenditure.

**1.** This Act may be cited as the Finance Short title (Supplementation and Variation of Appropriation) (Financial Year 2021) Act, 2021.

2. A further issue from the Consolidated Fund in the sum of two thousand, nine hundred and twenty-seven million, six hundred thousand and two dollars is authorised for meeting expenditure for the service of the financial year ending September 30, 2021 and appropriated in respect of the Heads of Expenditure set out in Part I of the Schedule to this Act.

3. The sums appropriated by the Appropriation (Financial Year 2021) Act, 2020 to the Heads of Expenditure specified in the First Column of Part I of the Schedule are increased by the amounts specified in the Second Column of that Part.

4. The sum appropriated by the Appropriation (Financial Year 2021) Act, 2020 to the Head of Expenditure specified in the First Column of Part II of the Schedule is reduced by the amount specified in the Second Column of that Part.

5. The sum appropriated by the Appropriation (Financial Year 2021) Act, 2020 in respect of the Head of Expenditure specified in the First Column of Part II of the Schedule and not utilised at the commencement of this Act may be utilised, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Heads of Expenditure specified in the First Column of Part I of the Schedule.
