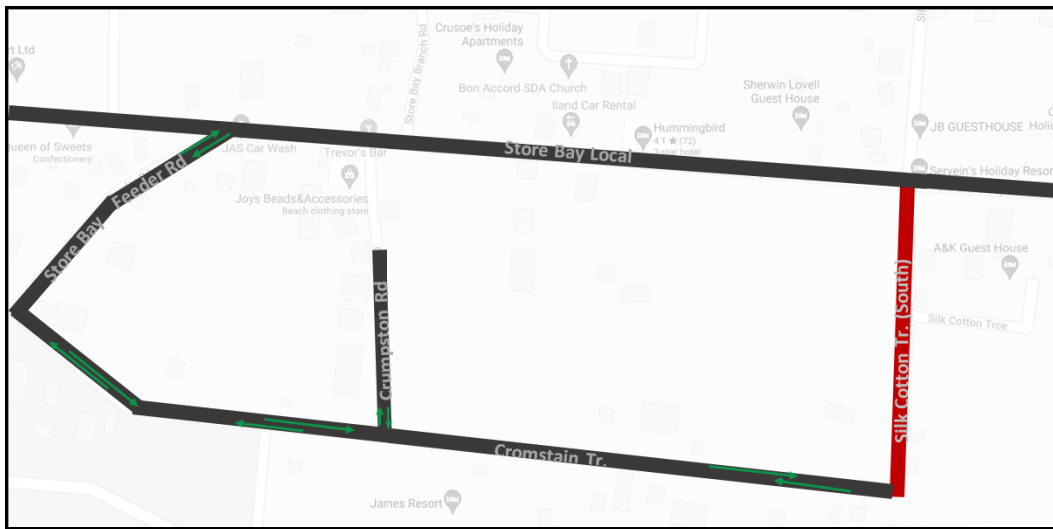

**Permanent Road Closure in Tobago: Silk Cotton Trace, Bon Accord**  
***(From Store Bay Local Road to Cromstain Trace)***

With effect from July 1<sup>st</sup> 2021, the southern segment of Silk Cotton Trace will be permanently closed from its intersection with Store Bay Local Road to its intersection with Cromstain Trace.



All persons accessing the Store Bay Local Road from the area (Crumpston Road and Cromstain Trace) should proceed west along Cromstain Trace and then North along Store Bay Feeder Road then exit to Store Bay Local Road.
