## APPOINTMENT OF A CUSTOMS BONDED AREA

(*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Vidyah Marcial, Acting Comptroller of Customs and Excise, acting under the provisions of sections 2 and 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private/Customs Bonded Area for the storage of machinery, equipment, raw materials, semi-manufactured goods and other ingredients, imported or taken out of Bond by Evolution Industries Limited, for the manufacture and packaging of cigarettes or other goods as may subsequently be approved.

### SCHEDULE

A two (2) storeyed building situated at D&D Warehousing, Lot No. 1, Sonny Ladoo Road, Mc Bean, Couva. Unit D, the fourth unit is located due east of unit C.

The building is a concrete and steel structure with galvanised roofing. The building comprises of two main doors on the southern side of the warehouse and measures 6.096 metres wide by 4.88 metres high (each). The building also has one pedestrian door located on the southern side of the warehouse and measures 1.98 metres high by 0.76 metres wide.

The Approved Undertaking Warehouse (AU) is located on the second floor inside Warehouse Number 4, measuring 6.096 metres by 7.56 metres equal to 46.09 square metres.

The warehouse is bounded to the east by road reserve (empty land) owned by E. Jordan, to the south bounded by road reserve and dwelling house owned and occupied by Ruby Stewart, and by an empty lot owned by S. Rampersad, bounded to the west by Sonny Ladoo Trace and to the north bounded by two apartment buildings owned by S. Kalloo and also bounded by Sonny Ladoo Trace Extension.
