### **PRACTICE DIRECTION**

### COURT OPERATIONS COVID-19 PANDEMIC DIRECTIONS WITH EFFECT FROM MAY 25, 2021 NO. 16

This Practice Direction is issued pursuant to Part 4 of the Civil Proceedings Rules 1998 (as amended), Part 20 of the Criminal Procedure Rules, Part 4 of the Family Proceedings Rules, Part 22 of the Children Court Rules, Rule 69 of the Petty Civil Court Rules and Rule 72 of the Non-Contentious Business Rules (as amended) and is applicable to the entire Judiciary of Trinidad and Tobago which includes the Supreme Court and all Summary Courts.

In response to the continuing surge in the novel coronavirus (Covid-19) cases in the Republic of Trinidad and Tobago, these Practice Directions are issued to protect the health and safety of court staff and the public.

Whereas the Judiciary of Trinidad and Tobago is committed to doing everything necessary to ensure continued access to justice and to keeping the Judiciary functioning while protecting our staff and our publics.

And whereas the Judiciary is desirous of:

- a) Reducing the number of persons coming to the nation's court buildings;
- b) Facilitating the use of electronic alternatives to in person activities at the Court by internal and external persons; and
- c) Making the courthouses and administrative offices as safe as possible for those who must physically attend those buildings;

having regard to:

- (a) the State of Emergency proclaimed on May 15, 2021;
- (b) the Emergency Powers Regulations in place from time to time;
- (c) the Public Health regulations in place from time to time; and
- (d) the Public Health policies in place.

PRACTICE DIRECTION No. 16—CONTINUED

The following measures shall take effect:

## **EFFECTIVE DATES**

 This Practice Direction shall be read in conjunction with the Practice Direction published in Trinidad and Tobago Gazette Vol. 60 No. 79 dated May 18, 2021 titled "Court Operations Covid-19 Pandemic Directions with effect from May 18, 2021 No. 15" and both shall take and continue to be in effect from May 26, 2021 to June 30, 2021 (this period) save and except paragraphs 3-7 and 11 of Practice Direction No. 15.

## **CLOSURE OF COURT BUILDINGS**

- 2. All Court Buildings shall be closed until June 30, 2021.
- 3. All Judiciary Virtual Access Customer Centres (VACC) shall be closed until June 30, 2021 save and except in any instance in which a witness in a matter deemed fit for hearing during this period is required to give evidence from a Judiciary Virtual Access Customer Centre.

## SITTINGS OF THE HIGH COURT AND SUMMARY COURTS

- 4. Hearings and/or sittings of the Supreme Court whether in person or virtual, are suspended save and except hearings of urgent matters deemed to be fit for hearing during this period, in the case of the Court of Appeal, by the Court or in the case of the High Court, by the Judge or Judicial Officer to whom a matter is docketed.
- 5. Hearings and/or sittings of the Summary Courts, including the Petty Civil Courts and Coroner's Courts whether in person or virtual, are suspended save and except hearings of urgent matters deemed by a District Court Judge, to be fit for hearing during this period.
- 6. Hearings of matters deemed to be fit for hearing during this period under paragraph 4, 5, or 14 shall be conducted virtually.
- 7. Where a virtual hearing is required in an emergency between the hours of 8:00 a.m. to 4:00 p.m., a party or witness to the proceedings may be required to appear at the appointed time from a particular place or from a Judiciary Virtual Access Customer Centre set out in **Schedule 1**, as directed by notice by e-mail, telephone or mail to the witness.
- 8. Where a hearing is required in an emergency between the hours of 4:00 p.m. to 8:00 a.m., which include the prohibited hours of movement under the Emergency Powers Regulations

2021, a party or witness to the proceedings may be required to give evidence from the specified Judiciary Virtual Access Customer Centres set out in **Schedule 2**.

9. Where a person is required in an emergency to give evidence under paragraph 8, in circumstances which require movement of anyone during the prohibited hours of movement under the Emergency Powers Regulations 2021, the Judiciary shall seek to have arrangements made with the Commissioner of Police for such movement.

### DEEMING MATTERS FIT FOR HEARING DURING THIS PERIOD

- 10. The Court may on its own motion, deem a matter to be fit for hearing in this period.
- 11. Any party to an action or to an intended action may apply to the Court to have a matter deemed fit for hearing in this period.
- 12. In the case of a Supreme Court matter, an application under paragraph 11 must be made in writing to the Registrar of the Supreme Court and must set out the facts and reasons which make the matter fit for hearing in this period.
- 13. In the case of a District Court or Summary Court matter, an application under paragraph 11 must be made in writing to the Magistracy Registrar and Clerk of the Court and must set out the facts and reasons which make the matter fit for hearing in this period.
- 14. Notwithstanding paragraph 5, for the purpose of this Practice Direction, the following matters are hereby deemed fit for hearing in the Summary Courts in any event during this period:
  - Domestic violence cases;
  - Maintenance applications including applications to vary orders to use CourtPay;
  - Urgent custody applications;
  - Detention of cash matters under the Proceeds of Crime Act;
  - Matters under the Emergency Powers Regulations, 2021; and
  - Charge matters.

# CERTIFICATION OF FEES FOR ATTORNEYS APPOINTED BY THE LEGAL AID AND ADVISORY AUTHORITY

15. Confirmation of appearance of attorneys in support of requisition of their fees shall be by data message provided in electronic form, signed and stamped electronically by the Judge or Judicial Officer and conveyed to the Legal Aid and Advisory Authority using the Judiciary's CourtMail system.
