THE CONSERVATION OF WILD LIFE (AMENDMENT) REGULATIONS, 2021

- 1. These Regulations may be cited as the Conservation of Wild Life Citation (Amendment) Regulations, 2021.
- 2. The Conservation of Wild Life Act is amended in the Second Second Schedule—

 - (a) by inserting Parts I and II as follows:

Quenk (Peccary or Wild Hog)

PART II

Birds—

Black Vulture (Corbeau) (Coragyps atratus)
Orange-winged amazon parrot (Amazona amazonica)

Ramier or pigeons: Scaled Pigeon (Columba speciose), Pale-vented Pigeon (Columba cayennensis), Eared Dove (Zenaida auriculata), Ruddy Ground-Dove (Columbina talpacoti), White-tipped Dove (Leptotila verreauxi), Gray-fronted Dove (Leptotila rufaxilla)"; and

- (b) in Part III by inserting—
 - (i) after the words "Cage birds which may be captured or kept captive by cage", the following:

"Cravat or Trinidad Euphonia (*Euphonia trinitatis*)
Parakeet or Green-rumped parrotlet (*Forpus passerinus*)
Semp or Violaceous Euphonia (*Euphonia violacea*)"; and

(ii) after the words "Cage birds which shall not be captured but may be kept captive by cage", the following:

 $\hbox{``Budgerigar'} (Melopsittacus\ undulatus)$

Canary (Serinus canaria)

Chats: Nun Chat or Lesson's seedeater (Sporophila bouyronides), King Chat or Lined seedeater (Sporophilia lineola),

Chicki-Chong, Bullfinch or Chestnut-bellied seed-finch (*Oryzoborus angolensis*)

Cockatiel (Nymphicus hollandicus)

Lovebirds (Agapornis spp.)

Picoplat or Grey seedeater (Sporophila intermedia)

Yellow-bellied seedeater (Sporophila nigricollis).".

Conservation of Wild Life Regulations amended Chap. 67:01

- 3. The Conservation of Wild Life Regulations are amended—
 - (a) in regulation 9—
 - (i) in subregulation (1), by deleting the words "with the exception of the animals listed in the Third Schedule of these Regulations";
 - (ii) by revoking subregulation (1A); and
 - (iii) in subregulation (2), by deleting the words "or (1A)"; and
 - (b) by deleting the Third Schedule.

Commencement 4. These Regulations are deemed to have come into effect on the 1st day of October, 2021.
