A PROCLAMATION

WHEREAS it is provided by section 2 of the CARIFORUM States (the Caribbean Community and the Dominican Republic) and the United Kingdom of Great Britain and Northern Ireland Economic Partnership Agreement Act, 2021 (hereinafter referred to as “the Act”) that the Act and the Agreement shall come into effect on such date as is fixed by the President by Proclamation:
