THE INSURANCE (AMENDMENT) BILL, 2022

Explanatory Notes

(These notes form no part of the Bill but are intended only to indicate its general purport)

This Bill seeks to amend the Insurance Act, 2018

The Insurance (Amendment) Bill, 2022 seeks to amend section 281 of the Insurance Act, 2018 (Act No. of 2018) ("the Act").

Clause 1 of the Bill provides for the short title.

Clause 2 of the Bill seeks to amend section 281 of the Insurance Act, 2018. Clause 2(a) seeks to amend section 281 (1) of the Act by replacing the eighteen month period for a foreign insurer to reorganize its business to June 30, 2023 or such later date as may be prescribed by the Minister under subsection (2A).

Clause 2(b) of the Bill seeks to amend section 281 (2) of the Act by replacing the eighteen month period for a foreign insurer to reorganize its business to June 30, 2023 or such later date as may be prescribed by the Minister under subsection (2A).

Clause 2(c) of the Bill seeks to amend section 281 of the Act by inserting a new subsection (2A) to empower the Minister of Finance, on the recommendation of the Central Bank of Trinidad and Tobago to extend the date of June 30, 2023 by Order, subject to negative resolution of Parliament.

1. This Act may be cited as the Insurance short title (Amendment) Act, 2022.

2. The Insurance Act is amended in section 281— Act No. 4 of 2018 amended

(a) in subsection (1), by deleting the words "for a period of eighteen months

("reorganisation period") from the this Act" commencement of and substituting the words "until 30th June, 2023 or such later date as may be prescribed by the Minister under subsection (2A) ("reorganisation period"),";

- (b) in subsection (2), by deleting the words "within a period of eighteen months from the commencement of this Act or within such shorter period as the Central Bank may direct" and substituting the words "on or before 30th June 2023 or such later date as may be prescribed by the Minister under subsection (2A)"; and
- (c) by inserting after subsection (2), the following new subsection:

"(2A) The Minister, on the recommendation of the Central Bank, may by Order, subject to negative resolution of Parliament, extend the date referred to in subsections (1) and (2).".
