THE FINANCE (VARIATION OF APPROPRIATION)
(FINANCIAL YEAR 2021) BILL, 2022

Explanatory Note

(This note forms no part of the Bill but is intended only to indicate its general purport)

The Bill seeks to vary the appropriation of sums, the issue of which was authorised by the Appropriation (Financial Year 2021) Act, 2020 (Act No. 24 of 2020) and varied by the Finance (Supplementation and Variation of Appropriation) (Financial Year 2021) Act, 2021 (Act No. 6 of 2021) and to authorise the utilisation of any sums accruing from a reduction in expenditure under certain Heads of Expenditure for the purpose of meeting liability incurred through the increase in expenditure under other Heads.

BILL

AN ACT to vary the appropriation of sums, the issue of which was authorised by the Appropriation (Financial Year 2021) Act, 2020 and varied by the Finance (Supplementation and Variation of Appropriation) (Financial Year 2021) Act, 2021

ENACTED by the Parliament of Trinidad and Tobago as Enactment follows:

1. This Act may be cited as the Finance (Variation of Short title Appropriation) (Financial Year 2021) Act, 2022.

Interpretation

2. In this Act, “the Appropriation Act, 2020” means the Appropriation (Financial Year 2021) Act, 2020 as amended by the Finance (Supplementation and Variation of Appropriation) (Financial Year 2021) Act, 2021.

Increase in Heads of Expenditure
Schedule

3. The sums appropriated by the Appropriation Act, 2020 to the Heads of Expenditure specified in the First Column of Part I of the Schedule are increased by the amount specified in the Second Column.

Decrease in Head of Expenditure
Schedule

4. The sums appropriated by the Appropriation Act, 2020 to the Head of Expenditure specified in the First Column of Part II of the Schedule are decreased by the amount specified in the Second Column.

Sums appropriated in respect of Head specified in Part II of Schedule may be utilised
Chap. 69:01
Schedule

5. The sums appropriated by the Appropriation Act, 2020 in respect of the Head of Expenditure specified in the First Column of Part II of the Schedule and not utilised at the commencement of this Act may be utilised, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Heads of Expenditure specified in the First Column of Part I of the Schedule.
