Explanatory Note

(This note forms no part of the Bill but is intended only to indicate its general purport)

The object of the Bill is to supplement the appropriation provided for by the Appropriation (Financial Year 2022) Act, 2021 (Act No. 14 of 2021) by authorising the issue from the Consolidated Fund in the sum of three thousand and eighty-one million, seven hundred and three thousand, nine hundred dollars (\$3,081,703,900).

A further issue from the Consolidated Fund in the sum of three thousand and eighty-one million, seven hundred and three thousand, nine hundred dollars is authorised for meeting expenditure for the service of the financial year ending September 30, 2022 and appropriated in respect of the Heads of Expenditure set out in the Schedule to this Act.
