AN ACT to amend the Soroptimist Club of Port-of-Spain
(Incorporation) Act, 1972 (Act No. 26 of 1972)

WHEREAS the Soroptimist Club of Port-of-Spain (here-^{Preamble}inafter referred to as “the Club”) was incorporated as a body corporate by the Soroptimist Club of Port-of-Spain (Incorporation) Act, 1972 (hereinafter referred to as “the ^{Act No. 26 of 1972} Act”):

And whereas the Soroptimist International Constitution was subsequently amended such that all

Soroptimist Clubs should be called Soroptimist International of the locality where they reside:

And whereas the Club is desirous of amending the Act to change its name to “Soroptimist International of Port of Spain” so that it may—

- Act No. 7 of 2019
- (a) comply with the Soroptimist International Constitution;
 - (b) register as a non-profit organisation under the Non-Profit Organisations Act, 2019; and
 - (c) carry out its operations, conduct its affairs and meet its legal obligations without difficulty and under one name:

Enactment Enacted by the Parliament of Trinidad and Tobago as follows:

Short title **1.** This Act may be cited as the Soroptimist Club of Port-of-Spain (Incorporation) (Amendment) Act, 2022.

Act No. 26 of 1972 amended **2.** The Soroptimist Club of Port-of-Spain (Incorporation) Act, 1972 is amended—

- (a) by deleting the words “the Soroptimist Club of Port-of-Spain” wherever they occur in the long title, the preamble and sections 3 and 5 and substituting in each place the words “Soroptimist International of Port of Spain”;
- (b) in the preamble—
 - (i) by deleting the words “from January, 1959”; and
 - (ii) by deleting the words “this Club” and substituting the words “this body”;
- (c) in section 1, by deleting the words “Soroptimist Club of Port-of-Spain” and substituting the words “Soroptimist International of Port of Spain”;

(d) in section 2—

- (i) by deleting the word “Organisation” and substituting the word “organisation”;
- (ii) by deleting the words “The Soroptimist Club of Port-of-Spain” and substituting the words “Soroptimist International of Port of Spain” and
- (iii) by deleting the words “The Club” and substituting the words “the Club”;

(e) in section 3—

- (i) by deleting the word “To” wherever it occurs and substituting in each place the word “to”; and
- (ii) by inserting the word “and” at the end of paragraph (d); and

(f) in section 4—

- (i) by inserting the word “and” at the end of paragraph (b); and
- (ii) in paragraph (c), by deleting the words “convey mortgage” and substituting the words “convey, mortgage,”.
