Public Statement of the Ombudsman of Trinidad and Tobago in accordance with section 7(4) of the Freedom of Information Act (FOIA) Chap. 22:02

Where a statement has not been published in accordance with section 7(1) of the Freedom of Information Act, Chap. 22:02 (the Act), the responsible Minister shall promptly give reasons, to be published in the Gazette for the failure to publish.

Whereas there is no Order by the President declaring a 'responsible Minister' for the Office of the Ombudsman (the Office) for the purposes of the Act pursuant to section 4 of the Act.

And whereas the Office has never published in the Gazette and daily newspaper in circulation the required annual statement in accordance with section 7(1) of the Act, the Ombudsman accordingly now provides the following reasons:

- i. The Office previously adopted the positon that it was not subject to the provisions of the Act.
- ii. On 13 July 2018 the Honourable Mr. Justice Ramcharan made the following Order in the matter of CV2016-01485 Vijay Singh v The Ombudsman:

"The Ombudsman is a 'Public Authority' within the meaning of and as defined by section 4 of the Freedom of Information Act 1999 as amended and is therefore subject to the Freedom of Information Act 1999".

- iii. Thereafter, the Office advocated for a Freedom of Information (Exemption) Order pursuant to section 5(1)(c) of the Act. The Office actively pursued this exemption from July 2018 and throughout the year 2019. The Office is of the view that the exemption is justified having regard to the requirement of privilege in the execution of its functions, as affirmed by the Constitution of the Republic of Trinidad and Tobago and the Ombudsman Act Chap. 2:52.
- iv. In the absence of the Exemption Order, the Office is cognizant of its duty to publish statements pursuant to sections 7, 8 and 9 of the Act. Due to administrative challenges however, it has not yet been accomplished.
- v. On 31 January 2020 Her Excellency Paula-Mae Weekes, ORTT President of the Republic of Trinidad and Tobago declared the 2019 Novel Coronavirus (the Covid-19 virus) to be a dangerous infectious disease. On 11 March 2020 the World Health Organization declared the Covid-19 virus a global pandemic and on 12 March 2020, Trinidad and Tobago confirmed its first case. In

response, the Government of Trinidad and Tobago imposed measures to mitigate the spread of the Covid-19 virus. These measures included, but were not limited to, various stay at home orders, mandatory office closures, a State of Emergency and staggered work arrangements to confine the movement of citizens and restrict working operations to those authorities/agencies that provided essential services. The Office was not designated an essential service and was thus closed for the following periods -31 March 2020 to 14 August 2020 and 30 April 2021 to 16 July 2021.

- vi. The Office operated at reduced staffing capacity, during the periods the Office was open from 17 August 2020 until 4 March 2022. Since resuming full operations on 7 March 2022, the Office's primary focus has been on addressing the vast increase in complaints from members of the public. These complaints allege administrative injustices in the public sector attributed in part to the measures implemented at various government agencies due the COVID-19 restrictions in Trinidad and Tobago from the year 2020 and continuing to 2022. There has also been an increase in the number of complaints filed pursuant to the Freedom of Information Act Chap. 22:02 (the FOIA).
- vii. The principal function of the Office is the investigation of complaints of maladministration against government departments and agencies by members of the public. The Office is also responsible for reviewing the decision of a public authority to refuse a request pursuant to the FOIA. The role and functions of the Office are set out in section 93(1) of the Constitution and section 38A of the Freedom of Information Act Chap. 22:02.

The Office regrets any inconvenience caused by the non-publication of the required statements and assures that its statement for 2022 will be published no later than 31 July 2022.

- A legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA.

Section 7 (1) (a) (i) Function and Structure of the Environmental Commission of Trinidad and Tobago Structure of the Commission:

The Commission is a Superior Court of Record established by the Environmental Management Act No. 3 of 2000 (The EM Act") Chap 35:05 and has in addition to the jurisdiction and powers conferred on it by the EM Act, all the powers inherent in such a Court. The Commission has the power to enforce its own orders and judgments, and the same power to punish contempts as the High Court of Justice.

The Environmental Commission is made up of six members who hear and determine environmental matters brought before the Court. Its Chairman and Deputy Chairman must be attorneys-at-law of not less than ten years standing. The other members must have knowledge and experience in environmental issues, engineering, urban and regional planning, the natural sciences or the social sciences. All six members are appointed by the President to hold office for term of not less than three years (Section 81 EM Act and section 14 of the Planning and Facilitation of Development Amendment Act 2019).

Functions of the Commission:

The Commission shall have jurisdiction to hear and determine -

- a) Appeals from decisions or actions of the Environmental Management Authority (EMA).
 Persons may challenge the EMA's findings, decisions and actions by appealing to the Commission.
- b) Applications for a deferment of a decision of the EMA under sections 25 and 41 of the EM Act 2000. Under Section 25, the EMA is authorized to make a decision to undertake emergency response activities as required to protect human health or the environment against threat of a pollutant,

hazardous substance or any other environmental condition. Under Section 41, the EMA may make a decision to designate portions of the environment as an environmentally sensitive area or species. When the EMA has made such decisions under sections 25 and 41 of the EM Act, the person who is affected by that decision, may apply to the Commission for a deferment of the decision on the grounds that it was unreasonable by section 88 (1) of the EM Act.

- c) Applications by the EMA for enforcement of the Consent Agreements and Final Administrative Orders under section 67 of the EM Act.
- d) Administrative civil assessments under Section 66 of the EM Act.
- Appeals from the designation of "environmentally sensitive areas or environmentally sensitive species" by the Authority pursuant to section 41 of the EM Act.
- f) Appeals from a decision by the Authority under section 36 of the EM Act, to refuse to issue a Certificate of environmental clearance or to grant such certificate with conditions.
- g) Appeals from any determination by the Authority to disclose information or materials claimed as a trade secret or confidential business information under section 23(3) of the EM Act 2000.
- h) Complaints brought by persons pursuant to section 69 of the EM Act known as the Direct Private Party Action provision. It is the only type of action before the Commission that does not involve the EMA as a party since one private individual brings an action against another private individual.
- i) Such other matters as may be prescribed by or arise under the EM Act, or any other written law where the jurisdiction of the Commission is specifically provided, such as the Urban and Regional Planning Profession Act No. 22 of 2020 and the Planning and Facilitation of Development Act No. 10 of 2014.


