In accordance with Sections 7, 8 and 9 of the Freedom of Information Act 1999 (FOIA), TTT Limited is required by law to publish and annually update the statements which list the documents and information generally available to the public.

The Freedom of Information Act gives members of the public:

- A legal right for each person to access information held by TTT Limited.
- A legal right for each person to have official information relating to himself/herself amended where it is incomplete, incorrect or misleading.
- A legal right to obtain reasons for adverse decisions made regarding an applicant's request for information under the FOIA
- A legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA.

Section 7 Statements

Section 7 (1) (a) (i)

TTTL is a State Enterprise, and it is wholly owned by the Government of the Republic of Trinidad and Tobago (GORTT). The Company is the national state broadcaster in Trinidad and Tobago. TTTL provides broadcast, production, and transmission services for audiences within Trinidad and Tobago and beyond. The broadcast services include a free-to-air television station (TTT), and three FM radio stations, (Talk City 91.1, Next 99.1 and Sweet 100.1).

TTTL was incorporated in August 2018. It took the place of the predecessor state media company, the Caribbean New Media Group (CNMG). There were no significant changes to the organization except for the brand name change.

TTTL's production resources include two (2) Outside Broadcast (OB) units for live event/production, two (2) major television studios, one (1) minor television studio, two (2) television control rooms and three (3) radio studios.

TTT Limited's free to air broadcast service is also carried on national cable services and online at <u>www.ttt.live</u> with social media activity on Facebook, Instagram and Twitter at tttliveonline. The television station and radio stations broadcast 24/7.

PUBLIC STATEMENT OF TRINIDAD AND TOBAGO TELEVISION LIMITED—CONTINUED

The Company engages about 160 persons, with a significant number of these being freelancers. Employees are hired on contract, the term of which ranges from one to two (1-2) years, depending on job seniority. Presently, TTTL's operational management is the responsibility of a management team of nine (9) managers, led by a Chief Executive Officer.

In November 2020, a Stabilization Plan for TTTL 2021-2022 was formulated and approved. The objective of the Stabilization Plan was to improve TTTL's commercial and operational performance and prepare the Company for the development of its Strategic Plan.

To develop positive national values and a well-informed and enlightened society through educational entertaining and informative programmes which are distributed in alignment with changing patterns of media consumption, and to be distinguished for the quality of local programme offering, inclusive of news and current affairs.

Vision Statement

To become the market leader in all our products and services by building sustainable brands and by moulding a viable and growth-oriented organization.

Corporate Information

TTTL's registered office is located at No. 11A Maraval Road, St. Clair, Newtown 190131. The Company is governed by a Board of Directors appointed by the Company's shareholder, Corporation Sole, on February 28th 2022, and are as follows:

Five (5) Board Sub-Committees assist in formulating and guiding the business and policies of the Company.

 Human Resources Committee - is responsible for creating and/or monitoring values-based systems and policies to ensure that the organization is following industrial laws and certain best practices relating to its employees and creating an attractive environment for current and prospective employees. The HR committee may also be responsible for policies regarding independent contractors and volunteers.

- Finance Committee Assist in setting the investment policy to be adopted for the management of Company funds as approved by the Minister of Finance (Corporation Sole) and ensure that the investment of Company funds is conducted in accordance with the investment policy and best practice.
- Tenders Committee The powers and rules of operation of the Tenders Committee with respect to the procurement process shall be determined by the Board of Directors from time to time. The Tenders Committee in accordance with the levels of authority, invite and consider Tenders for the supply of goods or services or works to be undertaken which are necessary for carrying out the objectives of TTTL and shall make recommendations on the acceptance or rejection of such Tenders. In addition, the Tenders Committee shall make recommendations to the Board on the disposal of obsolete assets and implement policy and procedures on Tendering, Procurement and Contracting, Pursuant to the full proclamation of the Public Procurement and Disposal of Public Property Act, 2015 the Tenders Committee will work in tandem with two Committees:
 - a) The Procurement and Disposal Advisory Committee.
 - b) The Disposal and Retention of Assets Committee.

The Procurement and Disposal Advisory Committee (PDAC) is one of the internal control mechanisms established within the operating framework of the Public Procurement and Disposal of Public Property to ensure that the objects of the Act are achieved. The PDAC does not approve evaluation reports or recommendations for awards. PDAC is a procedural safeguard set up to review and ensure that the evaluation committee follows the established procedures outlined in the TTT Limited's operating procedures.

The Disposal and Retention of Assets Committee is an independent committee. Its functions are to carry out physical inspection of the item, assess costs and benefits of disposal options, recommend the best disposal strategy or option, identify storage and transport issues, undertake the disposal process and evaluate, review and report on executed disposal process.

 Audit. Risk and Compliance Committee – appointed by the Board to assist in monitoring the periodic financial reports and other financial information provided by the Company to management or the public; reviews the Company's systems of internal controls regarding finance, accounting, legal, compliance and ethics that management and the Board have established, and the Company's auditing, accounting and financial reporting processes generally.

The Company was without a longstanding Chief Executive Officer from around 2014 up to 2019. Additionally, several critical senior management positions remained vacant up to that time. The Company was therefore hardpressed to meet certain obligations and was constrained in its ability to prepare and publish the requisite Freedom of Information Statements. The problems regarding the senior administration structure at the Company were rectified and regularized around 2019. Efforts have been made by the Ministry and the Company since then to satisfy all outstanding and current commitments.

These efforts were stymied, due to the 2019 Novel Coronavirus (2019-nCoV) and certain restrictions that were implemented by the Government of the Republic of Trinidad and Tobago ("GoRTT") to mitigate against the spread of the infectious disease and in particular to limit congregation and ensure social distancing protocols in the workplace.

Upon resumption of more normalized in-person working arrangements, efforts of the Ministry and the Company to satisfy all outstanding commitments continue. Please note that statements have since been published for the period 2021 and every effort is being made by the Ministry and the Company to publish the required section 7(1) Annual Statement for 2022 by July 31st 2022, in keeping with the statutory obligation arising under the Freedom of Information Act.
