Extensive experience in community medicine including considerable supervisory experience and training as evidenced by the possession of a medical qualification recognised by the Medical Board of Trinidad and Tobago supplemented by a recognised post-graduate qualification in Public Health or Community Medicine or any equivalent combination of experience and training.

Distinguishing Features of Work:

An employee in this class is responsible for organizing, planning, directing all activities relating to Community Health Services of the Nation. Work involves formulation of policies and programmes for general health care at primary levels, including maternal and child health, family planning, nutrition, school health, dental health and care for acute and chronic illnesses at health centres. Work also involves supervision of hospital services up to County Hospital level. Work entails overall supervision of a large group of professionals and other subordinates engaged throughout the nation in community health programmes. An employee in this class is required to exercise a high degree of independent professional and administrative judgement within the broad framework of established policies and procedures.
