#### EX-PARTE:

**UPON AN APPLICATION** for Injunctive Relief this day made unto this Honourable Court by Counsel for Party No. 1.

**UPON READING** the Notice of Application dated and filed herein on the 25th day of September, 2022 and the Affidavit of The Honourable Minister of Labour **STEPHEN MC CLASHIE** sworn to and filed on the said 25th day of September, 2022.

THAT the Court deems the contents therein are serious and warrant the urgent intervention of this Honourable Court.

#### IT IS HEREBY ORDERED:

THAT an Interim Order of an Ex-Parte Injunction is granted.

#### IT IS ORDERED THAT PARTY NO. 2:

- Whether by its President, Executive and/or members of the Teaching Service or otherwise whatsoever
  is hereby restrained from commencing and/or continuing and/or taking industrial action including
  "resting and reflecting" on the 26th day of September, 2022;
- Whether by its President, Executive and/or members of the Teaching Service or otherwise whatsoever is enjoined from commencing and/or continuing and/or taking industrial action.

#### IT IS ALSO ORDERED:

THAT Party No. 2 is directed forthwith through its President and Executive to instruct and/or direct its members of the Teaching Service to report for duty on the 26th day of September, 2022 and continuing as they are required to do in the normal course of their employment.

#### IT IS FURTHER ORDERED:

THAT leave is hereby granted to Party No. 1 to serve a copy of the said Notice of Application and Affidavit in Support together with a copy of this Order on Party No. 2.

THAT this Order of an Injunction be published in the Trinidad and Tobago Gazette and once in two (2) daily newspapers circulating in Trinidad and Tobago.

THAT this Injunction shall continue until further ordered.
