APPLICATIONS are invited from suitably qualified officers in your Ministry/Department for the office of Specialist Medical Officer, (Queen's Park Counselling Centre and Clinic) (Range 65), Ministry of Health.

Minimum Experience and Training Requirements:

Extensive experience (over eight years) in a specialist field of medicine and training as evidenced by the possession of a medical degree from a recognised school of medicine supplemented by the possession of a specialist diploma in the relevant field.

Additional Special Requirement:

Registration by the Medical Board of Trinidad and Tobago as a Medical Practitioner and as a Specialist in the relevant field.

Distinguishing Features of Work:

An employee in this class administers medical treatment to patients at a hospital in one of the specialist fields of medicine such as surgery, obstetrics, psychiatry or opthalmology. Work involves serving as a Consultant to lower level medical officers and attending clinics to treat patients. At a local county hospital, duties also include directing all professional and auxiliary services, but at the general hospital, work is confined to a specialist medical field. Work is performed independently and is subject to administrative review by a professional superior through conferences and analysis of reports and general observations.
