APPOINTMENT OF A PRIVATE WAREHOUSE  
(Customs Act, Chap. 78:01 Section 105)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chapter 78:01, I Vidyah Marcial, Comptroller of Customs and Excise, acting under the provisions of Section 263 (2) of the said Act, do hereby appoint the place specified in the schedule hereunder to be a Private Warehouse in the retail outlet of Messrs; Du Buy Duty Free Limited, for the storage of goods, pending entry for home consumption or export, as shall be warehoused, by Messrs; Du Buy Duty Free Limited of Piarco International Airport, Piarco, Site No. A2.004.01.1, Air Side East, 1st Floor, North Terminal, as follows : perfumes, liquors and such others goods as I may subsequently approve.

SCHEDULE

An enclosed area comprising of twenty point three, eight (20.38) square metres, with a length of approximately 10.03m running east to west, width of approximately 2.03m running north to south and a height of 3.5m. The area is situated approximately midway between gate Nos. 14 and 13, on the passageway. The shelving runs from east to west with firstly, six shelves high by six shelves across for display of perfumes to the western end. Secondly, located centrally, five shelves high by five shelves across for the display of liquor. Thirdly, to the eastern end of the kiosk, shelving, six shelves deep and two rows across with a sliding door on the left hand row and a rolling moveable cashier's table. All furnishings in the kiosk are mainly comprised of compressed board. There is a rolling vertical door of aluminium and clear hard-plastic material that closes off the southern end of the shop with gypsum walls on the western, northern and eastern ends of the shop.

REVOCATION OF APPOINTMENT OF A PRIVATE WAREHOUSE  
(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chapter 78:01, I, Vidyah Marcial, Comptroller of Customs and Excise, do hereby revoke the appointment of the place described in the Schedule hereunder as a Private Warehouse, which said place was appointed a Private Warehouse by the Comptroller of Customs and Excise for the storage, pending entry for home consumption or export, of certain goods as shall be warehoused by or in the Private Warehouse of Messrs., Du Buy Duty Free Limited of Piarco International Airport, North Terminal, Air Side East, 1st. Floor, under the provisions of Section 263(2) of the Customs Act, Chapter 78:01 and which said appointment was published as Notice No. 396 in the Trinidad and Tobago *Gazette* Vol. 56, No. 43 dated 18th April, 2017.

SCHEDULE

An enclosed area comprising of eighteen point five eight square metres (18.58 sq. m) length of approximately 10 metres running east to west, width of approximately 1.8 metres running north to south, with a height of 3.5 metres. The area is situated approximately midway between gates 14 and 13 and on the northern side of the passageway, opposite D'Trini Shop which is on the southern side of the passageway. The shelving runs from east to west with firstly, six shelves high by six shelves across for display of perfume to western end. Secondly, centrally located, five shelves high by five shelves across for the display of liquor. Thirdly, to the eastern end of the kiosk, shelving six shelves deep and two rows across with a sliding door on the left hand row and a rolling moveable cashier's table. All furnishings in the kiosk are mainly comprised of compressed board. There is a rolling vertical door of aluminium and clear hard-plastic material that closes off the southern end of the shop with gypsum walls on the western, northern and eastern ends of the shop.
