Particulars relating to the office are outlined below:

Minimum Experience and Training Requirements:

Extensive experience in Medical Microbiology and Training as evidenced by the possession of a Master's degree in the discipline of Medical Microbiology or any equivalent combination of experience and training.

Distinguishing Features of Work:

An employee in this class is responsible for organizing, planning, directing and co-ordinating all activities of the Trinidad Public Health Laboratory. Work involves planning programs for the Laboratory in collaboration with Senior Technical Officers of the Ministry of Health and ensuring the implementation of those programs. Work also includes direction of activities of professional, technical and other categories of staff at the Public Health Laboratory. The employee exercises consideration, independent, professional and administrative judgement in the performance of his function but work is subject to administrative review by a professional superior through conferences and analysis of reports for effectiveness.
