Public Statement of the Minister of Planning and Development

In Compliance with Section 7(4) of

The Freedom of Information Act (FOIA) Chap. 22:02

Where a statement has not been published in accordance with section 7(1) of the Freedom of Information Act, Chap. 22:02 (the Act), the responsible Minister shall promptly give reasons, to be published in the Gazette, for the failure to publish.

And whereas the Ministry of Planning and Development and the Caribbean Industrial Research Institute (CARIRI) and the National Trust of Trinidad and Tobago, both public authorities (Authorities) assigned to the Ministry of Planning and Development, have not published in the Gazette and a daily newspaper in circulation, the required annual statement in accordance with section 7(1) of the Act, the Minister accordingly now provides the following reasons:

On January 31st 2020 Her Excellency Paula-Mae Weekes, O.R.T.T., President of the Republic of Trinidad and Tobago, declared the 2019 Novel Coronavirus (2019-nCoV) to be a dangerous infectious disease. On March 11th, 2020 the World Health Organization declared the 2019 Novel Coronavirus (2019-nCoV) (hereafter called "the COVID-19 virus") outbreak as a global pandemic and Trinidad and Tobago confirmed its first case of the COVID-19 virus on March 12th, 2020. Subsequently, in an effort to mitigate the spread of the COVID-19 virus and to establish the parallel health care system, the Government of the Republic of Trinidad and Tobago ("GoRTT") imposed a Stay at Home Order effective March 30th, 2020 which confined the movements of citizens and restricted the usual work operations of Ministries and other public bodies to essential services only. In June, 2020 the public service was authorized to resume work subject to rotation of workers and other staggered work arrangements, designed to restrict congregation and ensure social distancing protocols in the work place. Normal operations were further stymied by additional Stay at Home Orders in the latter part of 2020 and again in May 2021. Inevitably, the normal operations and functioning of all public bodies were compromised.

A State of Emergency was proclaimed by the President of the Republic of Trinidad and Tobago on May 15th, 2021 which involved a curfew, in an effort to slow down the rapid spread of the COVID-19 virus and this continued to interrupt working operations. The State of Emergency expired on November 17th, 2021.

Upon resumption of more consistent in-person working arrangements, efforts are being made by the Ministry and the Authorities to satisfy outstanding and current commitments. The statutory requirement for the publication of an annual statement is one such commitment that was not satisfied and is being addressed.

Further, the National Trust of Trinidad and Tobago was impaired by a relocation exercise which involved the movement of the offices of the Authority to a new location. In November, 2020 the Cabinet agreed to the management of the Mille Fleurs building and adjoining structures by the National Trust of Trinidad and Tobago for their adaptive reuse and to the rental of the Mille Fleurs Building and adjoining structures. The Authority was therefore consumed with the rigours of relocating from Sackville Street, Port of Spain to Mews at Mille Fleur, Queens Park West, which move was completed on November 1st, 2021.

Every effort is being made by the Ministry and the Authorities to publish the required section 7(1) Annual Statement by end of March, 2022, in keeping with the statutory obligation arising from the Freedom of Information Act.

The Architecture Profession Act No. 19 of 1992 is an Act that governs the profession of architecture in Trinidad and Tobago. In order to protect the public interest, the Act establishes the Board of Architecture of Trinidad and Tobago (BoATT), which assesses the qualifications and experience of any person applying to become a Registered Architect, a title protected under the Act.

Prohibitions

Section 16 of The Architecture Profession Act, 1992
16. A person who is not a Registered Architect shall not:
(a) use any title or description that leads to the belief that he is a Registered Architect.

- (b) advertise himself as a Registered Architect.
- (c) act in a manner so as to create or induce the belief that he is a Registered Architect; or
- (d) sign or stamp any plans, drawings, designs, or specifications, purporting to be acting in the capacity of such Registered Architect.
