PRIVATE BILL—AN ACT TO AMEND THE TOBAGO COUNCIL FOR HANDICAPPED CHILDREN (INCORPORATION) ACT, 1975.

PUBLIC NOTICE is hereby given in accordance with House of Representatives Standing Order 75(3)(b) that the above-mentioned Bill will be introduced in the House of Representatives.

2. Notice of the intended introduction of the Bill is being given in the *Trinidad and Tobago Gazette* and copies of the Bill may be purchased from the Government Printer.

3. The object of the Bill, among other things, the Tobago Council for Handicapped Children (Incorporation) Act, 1975 and provide for a change in name of the organization to the Tobago Council for Children with Disabilities, in order to enable it to carry out its aims and objectives and specifically, to align the language used with inclusive, person-first terminology which is more widely accepted.

4. Any person wishing to be heard in opposition to the Bill must lodge a petition with the Clerk of the House showing the nature of his objections to the Bill and stating whether his objections extend to the whole Bill or to the clauses of the Bill.
