STATEMENT FROM SENATOR THE HONOURABLE RANDALL MITCHELL, MINISTER OF TOURISM, CULTURE AND THE ARTS IN ACCORDANCE WITH SECTION 7(4) OF THE FREEDOM OF INFORMATION ACT, CHAP. 22:02 ("FOIA")

By Trinidad and Tobago Gazette (Extraordinary) Vol. 59 No. 158 dated 9th day of September, 2020, the Culture and the Arts Division of the former Ministry of Community Development, Culture and the Arts was merged with the Ministry of Tourism, into a single entity, the Ministry of Tourism, Culture and the Arts ("the Ministry").


The Ministry is, by definition, a "public authority" under section 4 the FOIA and as such, is required to annually publish statements ("FOIA Statement") in accordance with sections 7, 8 and 9 of the FOIA. In full acknowledgment of the critical nature of this legislation, the Ministry continuously strives to maintain full and meticulous compliance with this statutory obligation. Notwithstanding, the Ministry omitted to publish its FOIA Statement for 2020.

This omission was attributed to the COVID-19 global pandemic as declared by the World Health Organization on the 11th day of March, 2020. Following this declaration, the Government of the Republic of Trinidad and Tobago ("GoRTT") implemented several periods of unprecedented restrictive protocols and policies pursuant to the Public Health Regulations with a view to limiting the movement of persons to prevent the spread of COVID-19, the effect of which invariably impacted upon the usual functioning of the entire Public Service.

In the remaining months of the year 2020, subsequent to the aforesaid merger, the Ministry was burdened with the management of its COVID-19 infection rates as well as with the myriad associated risks and quarantine requirements, which in some instances, severely crippled the full complements of the Ministry's Units. As a result, the normal operations and functioning of the Ministry were inevitably compromised. This was further exacerbated by the implementation of the GoRTT's stay-at-home initiatives for the Public Sector in an effort to reduce social interaction. Importantly, however, the Ministry in 2021, in accordance with the requirements of sections 7, 8 and 9 of the FOIA, published an FOIA Statement.

The Ministry fully recognises the paramount importance of compliance with the FOIA and will faithfully and unwaveringly continue in its compliance thereto. In the current year of 2022, the Ministry will continue to carry forward its compliance and shall cause prompt and accordant publication bringing up to date its 2021 FOIA Statement.



#### IN COMPLIANCE WITH SECTIONS 7, 8 AND 9 OF

#### THE FREEDOM OF INFORMATION ACT (FOIA)

In accordance with Sections 7 (1) (b), 8 (1) (b) and 9 (2) (b) of the Freedom of Information Act, (FOIA) the Zoological Society of Trinidad & Tobago Inc. (ZSTT) as required by law provides the following statements for 2021 which list the documents and information generally available to the public.

#### **Section 7 Statements**

#### Function and structure of the ZSTT

Mission Statement: The ZSTT oversees the provision and preservation of a representative collection of fauna of Trinidad and Tobago and other animals not indigenous to the twin island state, the introduction of new and curious objects of the animal kingdom; to ensure the efficient operations of a Zoological Park for the recreation and education of its people; and for the protection and conservation of the environment and our native fauna.

The ZSTT is a non-governmental private membership organisation established by an Act of Parliament, Act 12 of 1952. The ZSTT is divided into five (5) responsibility centres:

#### Details of Responsibility Centres

- (1) Council: Sets broad policy for the direction of the organization.
- (2) Curator's Office: Plans, organizes and directs all activities of the Emperor Valley Zoo.
- (3) Administrative Office: Keep all personnel records. Accounts payable and receivable. Process all correspondence. Human Resource Management.
- (4) Zookeeping Section: Animal care and maintenance.
- (5) Maintenance Section: Repair and maintenance of Infrastructure

#### Effect of functions on members of the public

Through the operation of the Emperor Valley Zoo, the ZSTT is involved in educating and sensitizing the public on the importance of wildlife conservation. The organization also provides a wildlife rescue and rehabilitation service to the public and advocates on matters of public concern e.g. effects of fireworks on animals.

Addressing Requests: To facilitate prompt handling of your request, please address it to the Designated Officer of the ZSTT (see Section 7 (1) (a) (vi).

Details in the request: Applicants should provide details that will allow for ready identification and location of the records that are being requested. If sufficient information is not provided clarification will be sought from the applicant. If you are not sure how to write your request or what details to include, communicate with our Designated Officer.

#### Requests not handled under the FOIA:

A request under the FOIA will not be processed to the extent that it asks for information, which is currently available in the public domain, either from the ZSTT or from another public authority, for example brochures and pamphlets etc.

#### Responding to your Request:

Retrieving Documents The ZSTT is required to furnish copies of documents only when they are in our possession.

Furnishing Documents: An applicant is entitled to copies of information we have in our possession, custody or power. We are required to furnish only one copy of a document.

Please note we are not compelled to do the following:

- (a) Create new documents.
- (b) Perform research for you.

#### Time Limits

General: The FOIA sets certain time limits for us to decide whether to disclose the documents you have requested. If we fail to meet the deadlines, the FOIA gives you the right to proceed as if your request has been denied. We will try diligently to comply with the time limits, but if it appears that processing your request may take longer than the statutory limit, we will acknowledge your request and advise you of its status. Since there is a possibility that requests may be misaddressed or misrouted, you may wish to call or write to confirm that we have received the request and to ascertain its status.

Time Allowed: We will determine whether to grant your request for access to information as soon as practicable but no later than 30 days as required by Section15 of the FOIA. If a decision is taken to grant access to the information requested, you will be permitted to inspect the documents or be provided with copies if you so request.
