## Section 7 (4)

### Reasons for the failure to publish statements as required under section 7 for the period 2016-2021

The Office of the Attorney General and Ministry of Legal Affairs ("the Ministry") regrets to advise that for the period 2016 to 2021, it was unable to publish its statements as is required under Section 7 of the Freedom of Information Act, 1999 ("the Act"). The inability to publish the Ministry's Statements were due to the following reasons:

1. The Ministry conducted a search of its records and found that no Statement was published by the Ministry of the Attorney General for the period 2010-2015. Furthermore, the Ministry of Legal Affairs last published a Statement in 2010 and thereafter did not publish any for the period 2011-2015. The Ministry of Justice published its only Statement in 2014. Therefore, the records for historical years were difficult to collate.
2. In September of 2015, the Government of the Republic of Trinidad and Tobago undertook the extensive exercise of merging the former Ministry of the Attorney General, Ministry of Legal Affairs and part of the Ministry of Justice into one (1) Ministry, now called the Office of the Attorney General and Ministry of Legal Affairs. As a result of such a resource-intensive exercise, and in the interest of preventing any disruptions to the provision and access of services, the Ministry resolved to focus its resources on the following:
  - i. The relocation of staff from the previously-named Ministries to one (1) central location at the Government Campus Plaza, AGLA Tower;
  - ii. Reclassification and harmonization of job functions;
  - iii. Incorporation and harmonization of services; and
  - iv. Specialist training of staff.

While the physical merging of the Ministry prolonged two (2) years, the logistical restructuring of the Ministry expanded six (6) years. Consequently, the Ministry was incapacitated in its ability to draft and publish the required statements.

3. Furthermore, these matters were compounded by the fact, that during said period, the Ministry had to address the issue of the turnover in persons holding the position of Administrative Officer V. During the period the Ministry had three (3) different officers in the position. Each officer did not hold the position for any lengthy period of time and this hindered the preparation of the statements required under the Act. The current Administrative Officer V is addressing all matters that come under her purview. The turnover of persons holding the Administrative Officer V has stymied some functions of the Ministry.
4. The Ministry, in compliance with the various Regulations and Guidelines issued by the Office of the Prime Minister and Ministry of Health, together with the Guidelines issued by the Service Commission Department and Chief Personnel Officer's Department in response to the Coronavirus Disease of 2019 (COVID-19) pandemic has been operating at a reduced capacity. The Ministry wishes to highlight that since 2020, its services has continuously been affected by mandatory office closures, restrictions in operating hours, restrictions in service provision, staff quarantine orders, staff rotations and office sanitations. Consequently, the Ministry has been constrained in directing its limited resources to the provision of essential services.

The Ministry sincerely apologises for any inconvenience caused by the non-publishing of its required statements for the period 2016-2021 and assures that its statement for 2022 will be published at the earliest opportunity.

By Trinidad and Tobago Gazette (Extraordinary) Vol. 59 No. 158 dated September 9th 2020, the Office of the Attorney General and Ministry of Legal Affairs ('the Ministry') was tasked with the responsibility of the following Statutory Boards and other Bodies which have not published their Freedom of Information Statements as required under the FOIA:

- i. Environmental Commission;
- ii. Equal Opportunity Commission;
- iii. Hugh Wooding Law School;
- iv. Industrial Court;
- v. Law Reform Commission; and
- vi. Tax Appeal Board.

According to section 7 of the FOIA, these Authorities are required to publish annual FOIA statements in the Gazette and in at least one daily newspaper in Trinidad and Tobago. The Authorities have not published their annual FOIA Statements for the reasons contained below:

1. The Authorities, in compliance with the various Regulations and Guidelines issued by the Office of the Prime Minister and Ministry of Health, together with the Guidelines issued by the Service Commission Department and Chief Personnel Officer's Department in response to the Coronavirus Disease of 2019 (COVID-19) pandemic has been operating at a reduced capacity. The Authorities wish to highlight that since 2020, their services have continuously been affected by mandatory office closures, restrictions in operating hours, restrictions in service provision, staff quarantine orders, staff rotations and office sanitations. Consequently, the Authorities have been constrained in directing its limited resources to the provision of essential services.
2. A State of Emergency was proclaimed by the President of the Republic of Trinidad and Tobago on May 15th 2021 which involved a curfew, which was meant to reduce the spread of the Covid-19 virus. This interrupted working conditions. The State of Emergency ended on November 17th 2021.

Upon resumption of a full complement of staff as of March 7th 2022, the Authorities are now in a position to satisfy outstanding commitments. One such commitment is the publishing of the FOIA Statements.

The Public Authorities with outstanding FOIA Statements are making every effort to publish the Statements as soon as possible.
