PRIVATE BILL—AN ACT TO AMEND THE TOBAGO COUNCIL FOR HANDICAPPED CHILDREN INCORPORATION) ACT, 1975.

PUBLIC NOTICE is hereby given in accordance with the House of Representatives Standing Order 75(3)(b) that the above-mentioned Bill will be introduced in the House of Representatives.

## Statement of the Minister of Sport and Community Development in accordance with Section 7 (4) of the Freedom of Information Act (FOIA) Chap. 22:02

The portfolio of the Ministry of Sport and Community Development (“the Ministry”) was established in the Trinidad and Tobago Gazette (Extraordinary) No. 158, Vol. 59 dated 9th September, 2020. Therein, the following Wholly Owned Enterprises were assigned to the Ministry:

- The National Commission for Self Help Limited (NCSHL),
- The Sport Company of Trinidad and Tobago Limited (SPORTT)
- The Export Centres Company Limited (ECCL)

Section 7(1) of the Freedom of Information Act, Chap. 22:02 (“the FOIA”), requires that each public authority, with the approval of the responsible Minister, cause a statement to be published in the Gazette and a newspaper in daily circulation. Further, where a statement has not been published in accordance with section 7(1) by a public authority, section 7(4) of the FOIA requires that the responsible Minister shall promptly give reasons for this omission, which shall be published in the Gazette. The three afore-named Wholly Owned Enterprises have not published annual FOIA statements since their assignment to the Ministry for the reasons stated herein.

Due to the Novel Coronavirus (2019-nCoV) outbreak which was declared a global pandemic by the World Health Organization in 2020, the Government of the Republic of Trinidad and Tobago through Public Health Regulations with effect from March 30, 2020 restricted movement of citizens and the operations of Ministries and other public bodies, limiting same to essential services. During the subsequent months, Public Health Regulations were routinely implemented in an effort to minimize congregation of persons, which resulted in fluctuations in operations. The stay-at-home orders which were instituted to strategically avoid physical interaction as a direct result of the pandemic, had the concomitant and unavoidable effect of disrupting workflow. ECCL was also particularly impaired by administrative transition during this period.

Additionally, a State of Emergency was proclaimed on May 15, 2021 with an attendant curfew, which lapsed on November 17, 2021 and further impacted regular operations of public bodies. The aforementioned public bodies experienced extended periods of closure between 2020 and the final quarter of 2021 which unfortunately led to their failure to publish annual FOIA statements.

The Minister of Sport and Community Development and the Ministry are committed to achieving the objectives of the FOIA, as well as the accountability and transparency that it facilitates. Therefore, with operations gradually normalizing from January 2022, NCSHL, SPORTT and ECCL are currently completing their annual FOIA statements for publication pursuant to section 7(1) of the Act, with a projected publication date of April 30, 2022.

Where a statement has not been published in accordance with section 7(1) of the Freedom of Information Act, Chap. 22:02 (the Act), the responsible Minister shall promptly give reasons, to be published in the *Gazette*, for the failure to publish.

And whereas the public authorities assigned to the Ministry of Trade and Industry (the Authorities), have not published in the *Gazette* and a daily newspaper in circulation; the required annual statement in accordance with section 7(1) of the Act, the Honourable Minister now states:

A stay at home order imposed by the Government of the Republic of Trinidad and Tobago with effect from March 30, 2020, constrained the movements of employees and therefore restricted the work operations of the Ministry and the Authorities. Subsequently, in June 2020 the public service was authorised to resume work subject to rotation of workers and staggered work arrangements, which limited the flow and movement in the work place. In addition, the operations were hindered by a stay at home order in the latter part of 2020 and again in May 2021 which interrupted the normal operations of the Ministry and the Authorities.

On May 15, 2021 a State of Emergency was proclaimed by the President of the Republic of Trinidad and Tobago which involved a curfew, in an effort to reduce the spread of the COVID-19 virus which again interrupted the normal operations of the Ministry and the Authorities.

Due to the State of Emergency expiration on November 17, 2021, which allows for the resumption of in-person working arrangements, every effort is being made by the Ministry and the Authorities to publish the required section 7(1) Annual Statement by end of March, 2022, in keeping with the statutory obligation arising from the Freedom of Information Act.
