THE MOTOR VEHICLES AND ROAD TRAFFIC (AMENDMENT) REGULATIONS, 2022

1. These Regulations may be cited as the Motor Vehicles and Road Traffic (Amendment) Regulations, 2022. Citation


2. In these Regulations, “the Regulations” means the Motor Vehicles and Road Traffic Regulations. Interpretation Chap. 48:50

3. The Motor Vehicles and Road Traffic Regulations are amended in— Regulation 19 and First Schedule amended

- (a) regulation 19, by inserting after the words “Form 5A”, the words “or Form 5AA”; and
- (b) the First Schedule, by inserting after Form 5A, the following form:
