THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(REPUBLIC OF TRINIDAD AND TOBAGO SIXTIETH
ANNIVERSARY OF INDEPENDENCE CELEBRATIONS
REHEARSAL) ORDER, 2022

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Republic of Trinidad and Tobago Sixtieth Anniversary of Independence Celebrations Rehearsal) Order, 2022. Citation

2. This Order has effect between 3.00 a.m. to 1.00 p.m. on Monday 22nd August, 2022, Wednesday 24th August, 2022 and Saturday 27th August, 2022. Duration

3. No person shall park a motor vehicle from— Parking prohibited

(a) 3.00 a.m. to 1.00 p.m. on—

(i) Serpentine Road, between Serpentine Place and Western Main Road;

(ii) St. Clair Avenue, between Elizabeth Street and Roxy Roundabout; and

(iii) Hayes Street, between Elizabeth Street and Serpentine Road; and

(b) 3.00 a.m. to 1.00 p.m. on Monday 22nd August, 2022, Wednesday 24th August, 2022 and Saturday 27th August, 2022 on—

(i) Western Main Road, between Roxy Roundabout and Long Circular Road; and

(ii) Long Circular Road, between Western Main Road and Patna Street.

4. No person shall drive a motor vehicle from—

(a) 3.00 a.m. to 1.00 p.m. on— Vehicular traffic prohibited

(i) Serpentine Road, between Serpentine Place and Western Main Road; and

(ii) Hayes Street, between Elizabeth Street and Serpentine Road; and

(b) 3.00 a.m. to 1.00 p.m. on Saturday 27th August, 2022 on—

(i) Western Main Road, between Roxy Roundabout and Long Circular Road; and

(ii) Long Circular Road, between Western Main Road and Patna Street.

Removal and
impounding
of vehicles

5. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
