ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(TOBAGO NATIONAL DAY OF REMEMBRANCE) ORDER,
2022

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Tobago National Day of Remembrance) Order, 2022.

2. This Order shall have effect from 6.00 a.m. to 1.00 p.m. on Duration Sunday 13th November, 2022.

3. A driver shall not drive his motor vehicle on—

Vehicular
traffic
prohibited

- (a) Jerningham Street;
- (b) Ross Street;
- (c) Piggott Street, from the junction of Burnett Street to Bacolet Connector Road;
- (d) Bacolet Connector Road, from the junction of Piggott Street to the junction of Main Street and Bacolet Street;
- (e) Main Street, from the junction of Main Street and Bacolet Street to the junction of Main Street and Burnett Street;
- (f) Burnett Street; and
- (g) Bacolet Street, from the corner of Main Street and Bacolet Street to Hay Street and Young Street,

during the hours of 6.00 a.m. to 1.00 p.m. on Sunday 13th November, 2022.

4. A driver of a motor vehicle shall not park on—

Parking
prohibited

- (a) Jerningham Street;
- (b) Ross Street;
- (c) Piggott Street, from the junction of Burnett Street to Bacolet Connector Road;

- (d) Bacolet Connector Road, from the junction of Piggott Street to the junction of Main Street and Bacolet Street;
- (e) Main Street, from the junction of Main Street and Bacolet Street to the junction of Main Street and Burnett Street;
- (f) Burnett Street;
- (g) Old Market Car Park and Piggott Street; and
- (h) Bacolet Street, from the junction of Main Street and Bacolet Street to Hay Street and Young Street,

during the hours of 6.00 a.m. to 1.00 p.m. on Sunday 13th November, 2022.

Parking permitted

5. Parking is permitted at—

- (a) Republic Bank Car Park, Burnett Street for specially invited guests; and
- (b) Gardenside Street Car Park for the public,

during the hours of 6.00 a.m. to 1.00 p.m. on Sunday 13th November, 2022.

Removal and impounding of vehicles unlawfully parked

6. Without prejudice to any other liability incurred by the commission of a traffic violation, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
