THE BREWERY ACT, CHAP. 87:52

ORDER

Made by the Minister under section $34A\left(1\right)$ of the Brewery $$\operatorname{Act}$$

THE BREWERY (MANUFACTURE OF BEVERAGES) ORDER, 2022

1. This Order may be cited as the Brewery (Manufacture of Citation Beverages) Order, 2022.

2. In this Order, "Brewer" means Tommy's Brewing Company Interpretation Limited Shop of #19A Movietowne, Port-of-Spain.

3. (1) The Minister authorises the Brewer to manufacture the Authority to following products on the premises of the Brewer subject to the terms manufacture beverages and conditions in subclause (2):

- (a) hard cider in the flavour of sorrel, apple, pear, guava, pomegranate, watermelon, passionfruit, pineapple, strawberry, grapefruit, honey, lemon, orange, cranberry, kiwi, raspberry or peach [(58.5L Kegs (1/2BBL)) up to 7.5% of alcohol];
- (b) hard cider in the flavour of sorrel, apple, pear, guava, pomegranate, watermelon, passionfruit, pineapple, strawberry, grapefruit, honey, lemon, orange, cranberry, kiwi, raspberry or peach [(20L Kegs (1/6BBL)) up to 7.5% of alcohol];
- (c) hard cider in the flavour of sorrel, apple, pear, guava, pomegranate, watermelon, passionfruit, pineapple, strawberry, grapefruit, honey, lemon, orange, cranberry, kiwi, raspberry or peach [(275ml) up to 7.5% of alcohol];
- (d) hard cider in the flavour of sorrel, apple, pear, guava, pomegranate, watermelon, passionfruit, pineapple, strawberry, grapefruit, honey, lemon, orange, cranberry, kiwi, raspberry or peach [(330ml) up to 7.5% of alcohol];
- (e) hard seltzer in the flavour of sorrel, apple, pear, guava, pomegranate, watermelon, passionfruit, pineapple, strawberry, grapefruit, honey, lemon, orange, cranberry, kiwi, raspberry or peach [(58L Kegs (1/2BBL)) up to 8% of alcohol];

- (f) hard seltzer in the flavour of sorrel, apple, pear, guava, pomegranate, watermelon, passionfruit, pineapple, strawberry, grapefruit, honey, lemon, orange, cranberry, kiwi, raspberry or peach [(20L Kegs (1/6BBL)) up to 8% of alcohol];
- (g) hard seltzer in the flavour of sorrel, apple, pear, guava, pomegranate, watermelon, passionfruit, pineapple, strawberry, grapefruit, honey, lemon, orange, cranberry, kiwi, raspberry or peach [(275ml) up to 8% of alcohol]; and
- (h) hard seltzer in the flavour of sorrel, apple, pear, guava, pomegranate, watermelon, passionfruit, pineapple, strawberry, grapefruit, honey, lemon, orange, cranberry, kiwi, raspberry or peach [(330ml) up to 8% of alcohol].

(2) In manufacturing the beverage referred to in subclause (1), the Brewer shall comply with the following terms and conditions:

- (a) the manufacturing process shall be submitted to the Officer;
- (b) twenty-four hours advance notice shall be submitted to the Officer prior to the commencement of the manufacturing process;
- (c) the dissolving and collecting vessels shall be clearly identified;
- (d) the Brewer shall keep a register and that register shall show particulars pertaining to—
 - (i) the quantity and description of raw materials received;
 - (ii) the quantity and description of raw materials issued for the manufacturing process;
 - (iii) the quantity and description of the finished product after bottling; and
- (e) all operations shall be subject to the Officer's supervision.
