- Applicant must be registered with Ministry
- Fishing Vessel must be registered with Ministry
- Proof of authorization to use land (copies of deed, notarized letter of authorization etc.)
- Proof of original receipts for goods and services

GENERAL PROCEDURES FOR APPLICATION

- Visit county office where registered/ Fisheries Head Office
- Present Farmers ID/Fisherman's Certificate and National ID bearing applicant's photo
- Verification of agricultural/fisheries activity by an Extension Officer

- **Citizen of Trinidad and Tobago**
- **17 years and over**
- **Valid National I.D. Card/Trinidad and Tobago Passport/
Naturalization/Driver's Permit**
- **Two (2) passport size pictures**
- **Proof of ownership with respect to vessel(s) and engine(s) or
proof of interest in the land being farmed**
