TENDERS are invited for the supply and delivery of Two (2) Modular Steel Bridges to the Ministry of Works and Transport.

- (i) valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) Certificate of Compliance issued in accordance with the National Insurance Act.
