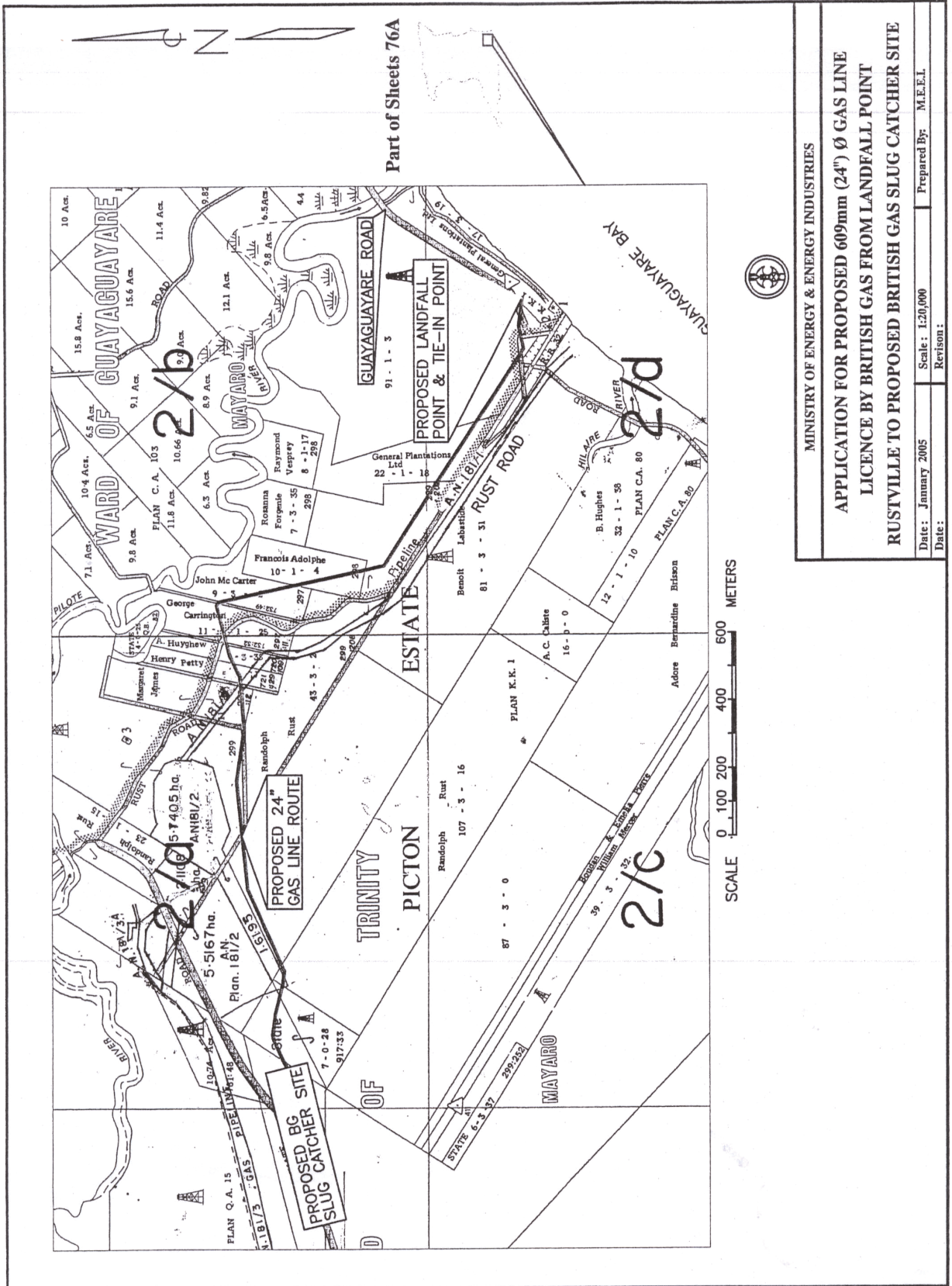
<i>Route</i>	The proposed 609 mm (24-inch) onshore pipeline will begin at Rustville at a connection to a proposed 609 mm (24-inch) offshore pipeline on the southeastern coast of Trinidad and will proceed in a general north westerly direction. At approximately 80 m (262 ft.) from landfall, the pipeline will join the National Gas Company's (NGC) 914 mm (36-inch) gas pipeline Right of Way (BUD ROW) for approximately 1368 m (4488 ft.). As the said pipeline parallels the BUD 914 mm (36-inch) gas pipeline, no major water courses will be encountered, but the pipeline will cross the Guayaguayare Road, several minor and seasonal drains, one low-lying area, several minor roads, and several foreign lines before deviating from the BUD ROW. It will then cross the BUD 914 mm (36-inch) line and the BHP Billiton 457 mm (18-inch) crude oil line.
				The proposed line will then cross the Guayaguayare Road a second time, skirt an existing Petrotrin well and cross two major pipelines, that is, the bpTT 1016 mm (40-inch) and 1219 mm (48-inch) gas pipelines and a paved access road. The remainder of the route will be through undulating forested area and the proposed pipeline will skirt the southern edge of the bpTT Beachfield slugcatching facility before terminating at a proposed British Gas slugcatching facility. 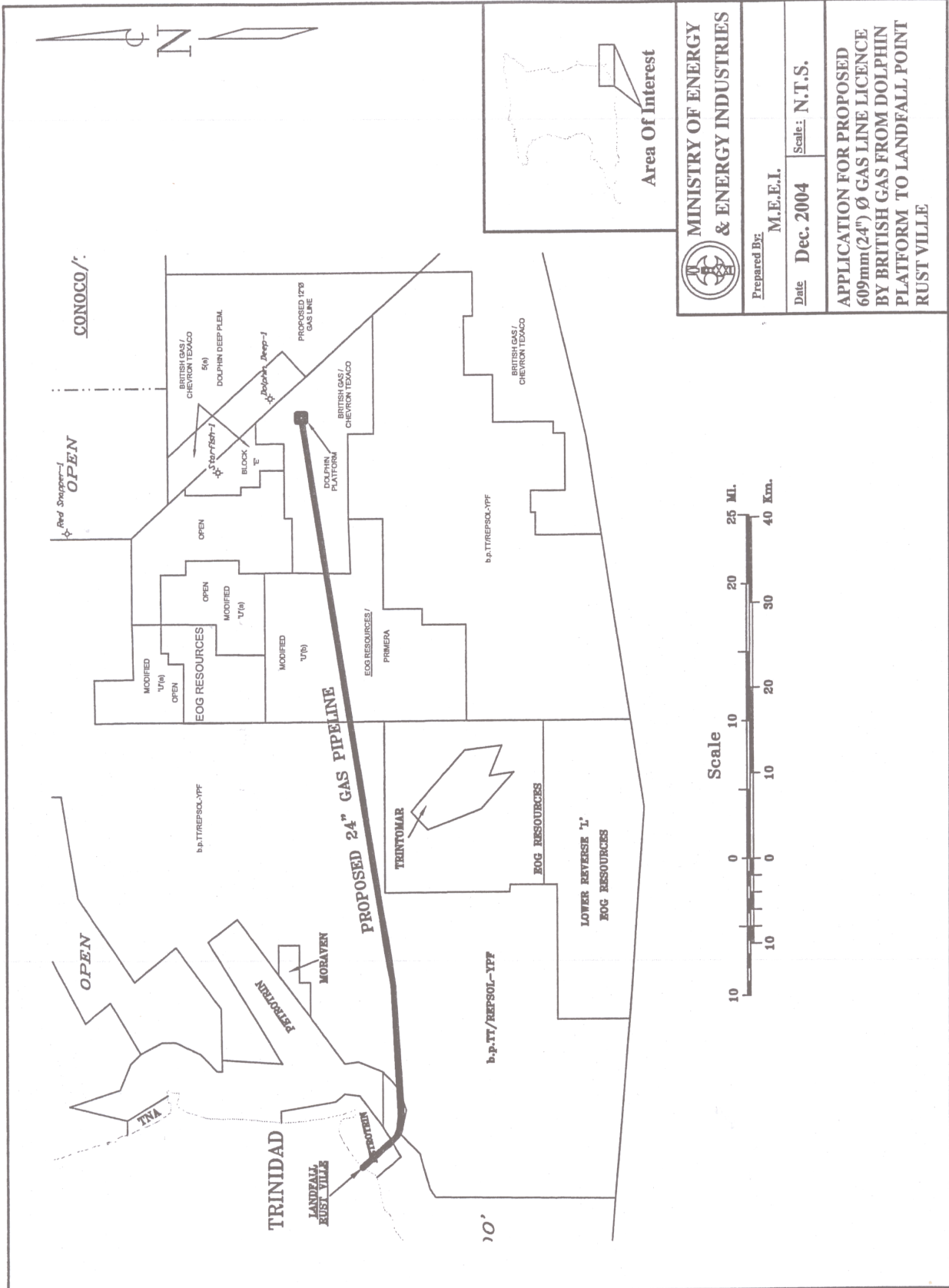
