CONDITIONS OF SALE:

- (1) Eighty vehicles conform to the Ministry of Trade and Industry guidelines. Approval is granted for the sale of these vehicles to be registered for the roads of Trinidad and Tobago.
- (2) Twenty-five vehicles did not meet the requirements and approval will be granted for sale by auction to be scrapped for parts only.
- (3) Three trailers will be sold on conditions specified by the Licensing Authority.
