#### INTRODUCTION

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act (FOIA) 1999, e TecK is required to publish an updated public statement setting out certain information for the benefit of the public. The Statement describes e TecK's organisation, functions, decision-making powers and arrangements for consultation in the formulation of policy. The Statement also lists the categories of documents that are available for inspection by the public and how to access the documents which are eligible for public scrutiny.

# The FOIA gives members of the public:-

- (1) A legal right for each person to access information held by e TecK;
- (2) A legal right for each person to have official information relating to him/herself amended where it is incomplete, incorrect or misleading;
- (3) A legal right to obtain reasons for adverse decisions made regarding an applicant's request for information under the FOIA;
- (4) A legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA.

#### (i) STATEMENT OF ORGANISATION AND FUNCTIONS OF E TECK

#### **Company History**

Incorporated in 1997 to manage the Industrial Estates previously owned by the Industrial Development Company of Trinidad and Tobago (IDC), the Property and Industrial Development Company of Trinidad and Tobago Limited (PIDCOTT) in June 2003, was transformed from a subsidiary of the Tourism and Industrial Development Company of Trinidad and Tobago Limited (TIDCO) to an independent State enterprise (eTecK) with an entirely new mandate to develop the Wallerfield Industrial and Technology Park (now called the Tamana InTech Park) and to develop the non-energy business and knowledge- and technology-driven sector and the light industrial sector.

The name was changed from PIDCOTT to Evolving TecKnologies and Enterprise Development Company Limited (e TecK) in October 2004 so as to more adequately represent the expected new role of catalyst for the transformation of the economic life of Trinidad and Tobago, by transforming the export base and the skill levels of the citizens.

#### e TecK's Mandate

e TecK is responsible for developing the light Industrial estates in Trinidad and Tobago by encouraging diversification of the country's production and export bases, exploring niche areas of investment for local and foreign investors, as well as providing infrastructural support by development of e TecK Parks throughout Trinidad and Tobago.

More specifically, the Mandate is interpreted as enabling e TecK to pursue the following activities:

- To foster the sustainable industrial and economic development of the light industrial sector of Trinidad and Tobago through diversification of the production and export base;
- o Industrial Site development;
- o Development and upgrade of existing Industrial Parks;
- Non-energy Sector Business Development, including the development of the ICT, knowledge-based and downstream energy industries;
- o Ownership, development and management of the Tamana InTech Park;
- Management of the lease operatorship for the hotel operated by Hilton Hotel Corporation in Trinidad and in Tobago;
- o Rationalising responsibility for the management of the operation arrangements for Hilton Trinidad and Conference Centre and VHL Tobago Golf and Spa Resort (formerly Tobago Hilton) (in which there is State participation);
- o Resolution of the issues surrounding the Tobago hotel and developing proposals for the protection of Government's interest;
- Monitoring the business ventures established under the Equity Fund (to be established to provide venture capital funding for start ups in the on-shore economy by taking equity positions in innovative small business ventures);
- o Development and delivery of non-energy Industrial sector incentives;
- Development of the onshore industrial base through opportunities provided by the downstream aluminum sector, other downstream energy industries and the ICT industry;
- o Development of a state-of-the-art project management capability for Trinidad and Tobago;
- Collaborating with National Energy Corporation (NEC) and Tourism Development Corporation (TDC) in the development of promotional strategies as well as material on Trinidad and Tobago.
- Investment Promotion

The deliverables include the development of light industrial estates, a number of investment projects delivered within budget and timeframe, the expansion of local business, employment creation, increased production and export base. The Target Client is the Industrial sector with an asset base of over \$250,000.00.

## Organisational Structure and Functions of e Teck

e TecK is led by a President who reports to a Chairman and Board of Directors. The Company comprises the following Divisions as shown on the Organisational Chart:



These Divisions are located at e TecK's Head office and are managed by Vice Presidents. The portfolios of Corporate Communications, Financial Services and Information, Communication and Technology (ICT) report directly to the Office of the President. e TecK's line Ministry is the Ministry of Trade and Industry.

The Ministry stakeholders of e TecK are the Minister of Finance in his capacity as Corporation Sole (sole shareholder), the Ministry of Trade and Industry and the Ministry of Science, Technology and Tertiary Education. Other stakeholders are Trinidad & Tobago Manufacturers Association, Trinidad & Tobago Chamber of Industry & Commerce and e TecK's tenants.

#### Particulars of the Organisation and Functions of e TecK

#### Office of the President

The Office of the President is entrusted with the responsibility and accountability for the company's Deliverables as mandated by the Government of Trinidad and Tobago and carefully monitors the company's four Divisions (namely Business Development, Capital Projects, Property Management and Corporate Administration) to ensure that the deliverables of each Division are executed to prevent any negative impact on the management and performance of the company.

The Office of the President is also responsible for the efficient and effective management of the company's corporate communication, prudent financial management of the company's financial resources and the implementation of the ICT infrastructure and network.

## **Business Development Division**

#### 1. Medical Data Caribbean Limited (MDCL)

The Medical Data Caribbean Ltd is a wholly owned subsidiary of e TecK, established in 2004 to provide Medical Transcription Services to US based clients.

Medical Transcription involves taking dictated medical information and transforming it into a uniformed, permanent electronic or physical (printed) record or document via a word processor or a typewriter. More traditionally speaking, transcribing is changing oral dictation (spoken words) into written form.

## 2. Valeo Software Limited ("Valeo")

The Trinidad & Tobago joint venture Software Development Company is owned by e TecK and InterFix Ventures LLC. Directors Monteil and Copeland were appointed e TecK's directors on the Board of the Company with eTecK's President Khalid Hassanali. Valeo is responsible for the development of the information technology platforms and computer software for e TecK's medical transcription venture, for the medical transcription industry generally, and for the production of enhancements and upgrades to such software.

## 3. InterFix Ventures LLC ("IV")

The US based marketing and technical joint venture company is incorporated in the US and owned by InterFix Ventures LLC and e TecK. Director Tiah was appointed e TecK's director on the Board of InterFix Ventures with Beverley John, e TecK's Senior Vice President as alternate director. IV was established to provide marketing, distribution and other related services to e TecK's medical transcription venture specifically and others generally as determined by the company.

## 4. Vanguard Hotel Limited ("VHL")

In 2008, VHL became a wholly owned subsidiary of e TecK, charged with the responsibility of giving direction to the VHL Tobago Golf and Spa Resort, formerly the Hilton Tobago Golf and Spa Resort.

#### **General Procedure**

# **Addressing Request**

To facilitate prompt processing, all requests should be addressed to e TecK's Designated Officer. Please refer to Section 7(1)(a)(vi) for further details.

# **Details in Request**

Applicants should provide details that will allow for ready identification and location of the documents that are being requested. If insufficient information is provided, clarification will be sought from the applicant. If the applicant is unsure as to how to adequately complete the form, please contact the Designated Officer who will take all reasonable steps to render the necessary assistance.

# REQUESTS NOT HANDLED UNDER THE FOIA

A request under the FOIA will not be processed to the extent that it asks for access to documents which are classified as exempt under Part IV of the FOIA or documents falling under Section 12 FOIA.

# RESPONDING TO THE REQUEST

## **Retrieving Documents**

e TecK is required to furnish copies of documents only when they are in its possession or can be retrieved from storage.

#### **Furnishing Documents**

The applicant is entitled to access to all documents to which the FOIA applies. Copies of the documents, if requested, will be furnished within seven (7) calendar days. If a legible copy cannot be produced, no attempt will be made at reconstruction. However, the best copy possible will be furnished and its quality noted in the reply.

Please note there is no duty upon e TecK under the FOIA to do the following:

- (a) Create new documents;
- (b) Perform research for the applicant.

#### TIME LIMITS

#### General

The FOIA prescribes a Time limit of thirty (30) calendar days for e TecK to communicate to the applicant, its approval or refusal of a request for access to documents. e TecK will make all attempts to adhere to this time limit, however, if it appears that the processing of the request will not be within the said time limit, e TecK will advise the applicant of same. If e TecK fails to meet the thirty (30) day deadline, the FOIA gives the applicant the right to proceed as though his/her request has been denied.

The possibility exists that requests may be incorrectly addressed or misdirected. Applicants are asked to call or write to confirm that e TecK has received the request, and to ascertain its status.

#### Time Allowed

e TecK will determine whether to grant the applicant's request for access to information as soon as practicable, but no later than thirty (30) days, as required by Section 15 of the FOIA. If a decision is taken to grant access to the information requested, the applicant will be permitted to inspect the documents and/or be provided with copies.
