- Leasing of industrial sites.

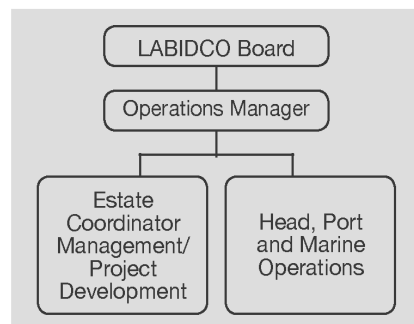

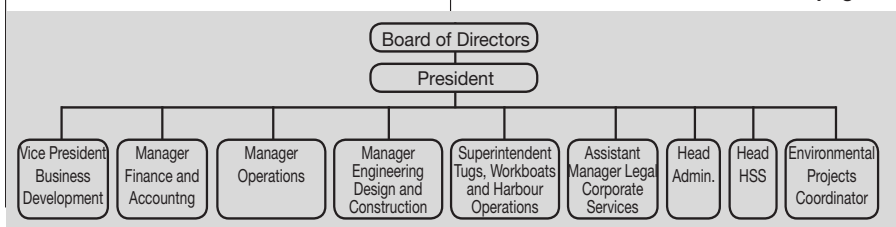
